GENERAL TERMS & CONDITIONS: Please read this agreement carefully before sending any money.

Tour Cost: The price of the Chamber Music Society - Music@Menlo tour to London-Paris is \$12,850 per person, ground only. This price is based on double-occupancy, and a minimum of 20 persons. Single supplement is \$2000. See note under Accommodations on the reverse. Tour cost includes a \$1250 tax-deductible contribution to the Chamber Music Society of Lincoln Center (CMS). The tour is organized by The Grand Tour (TGT), Peterborough, New Hampshire

Tour Cost Includes: Eight (8) nights hotel accommodations at five-star hotels in London and Paris • Daily buffet breakfast • 4 dinners and 3 lunches, an afternoon tea, plus 3 receptions • At least 4 public and private concert performances by David Finckel, Wu Han and other musicians • Private tours of principal sites in London and Paris by expert guides • Private motor coach transportation for all excursions mentioned in the itinerary • Private round-trip transfers from London airports to London hotel, and Paris hotel to Paris airports • Private guides for all activities mentioned in the itinerary • Entrance fees for all scheduled museum visits and other attractions in the itinerary • Services of TGT tour manager throughout the tour • All gratuities for meals, bus drivers, local guides and tour manager • Travel tips and suggested reading lists • Maps of London and Paris • Two CMS luggage tags

Reservations and Method of Payment: The deposit for the tour is \$1,250 per person, and is first come, first served. Payment is accepted by check or money order made out to The Grand Tour, or credit card (Visa, MasterCard, or AMEX). \$500 of the deposit is non-refundable.

Upon receipt of deposit The Grand Tour will send a letter of confirmation, balance invoice and travel insurance information. TGT accepts checks made to The Grand Tour, Visa, MasterCard and American Express. CMS will bill contribution amount separately. Prior to departure, additional items of interest will be mailed to the participants. If you have any questions please contact Sharon Griffin at CMS (212) 875-5782, or The Grand Tour (800) 727-2995. Please note that tour participation is limited to 30 participants or as hotel space allows.

Final Payment: The final balance must be received at CMS or The Grand Tour by <u>Friday, August 17, 2018</u>.

Rates: Prices quoted are based on fares in effect at the time of printing and are subject to change prior to departure. Prices could increase due to below minimum participation. Participants will be notified of any such price increase at least 30 days prior to departure.

Cancellations: You are entitled to a full refund if the tour is cancelled by CMS or The Grand Tour. If you should cancel, there is a non-refundable \$500 fee. The remaining balance (minus the \$500 fee) will be refunded according to the following schedule:

Before July 21, 2018: 100%
July 21 – August 3, 2018: 50%
August 4 – 18, 2018: 25%
After August 18, 2018: 0%

Ticketed passengers must return unused tickets and any other negotiable vouchers for an applicable refund to be processed. Once travel begins, any change made by a passenger is the responsibility of the passenger.
