 Goddard Consulting re-delineated the wetland in December 2014 on behalf of owner
 Capital Group Properties and is requesting an amendment to the ORAD to reflect the
 new wetland line.
- Continued public hearing to consider a Notice of Intent and an application for 7:15 Stormwater Management Permit filed by Martin Loiselle, Capital Group Properties, for the construction of four apartment buildings, a club house, associated driveway and parking areas, stormwater management system, utilities and site grading on 7.62 acres of land, portions of which are bordering vegetated wetlands.
