Narrative:

Yorktown Police report the arrest of twenty-nine year old Perry D. Freeman of 3469 Lexington Ave., Mohegan Lake, NY who is charged with Criminal Possession of a Controlled Substance 3rd Degree, Class "B" Felony (2 Counts), Criminal Sale of a Controlled Substance 3rd Degree, Class "B" Felony (2 Counts), Criminal Sale of a Controlled Substance 5th Degree, Class "D" Felony (3 Counts), Criminal Possession of a Weapon 3rd Degree, a Class "D" Felony, Criminal Possession of a Controlled Substance 7th Degree, Class "A" Misdemeanor and Criminal Possession of a Hypodermic Instrument, a Class "A" Misdemeanor. Police also report the arrest of twenty-five year old Almira Canoski of 14 Helin Rd., Hopewell Junction, NY who is charged with Criminal Possession of a Controlled Substance 7th Degree, Class "A" Misdemeanor.

On November 2, 2015, members of the Yorktown Police Department and the Northern Westchester Drug Task Force executed a search warrant at 3469 Lexington Ave. and arrested Perry D. Freeman after a lengthy investigation. It is alleged that Freeman sold heroin to another person on two dates in October, 2015. Subsequent to executing the search warrant, police allege that Freeman was also in possession of a large amount of heroin, an illegal, unregistered handgun and hypodermic needles. Also arrested was Almira Canoski, who was at Freeman's residence during his arrest and was allegedly in possession of heroin.

Freeman and Canoski were processed on the above charges at Yorktown Police Headquarters. Freeman was remanded in lieu of bail to the Westchester County Jail by the Honorable Salvatore Lagonia. He is scheduled to appear in Yorktown Justice Court on November 10, 2015 at 6:00 pm. Canoski was released on her own recognizance and is scheduled to appear in Yorktown Justice Court on December 3, 2015 at 6:00 pm.
