Narrative: Yorktown Police report the arrest of 21 year old Lucas Rodriguez of Yonkers, NY and a 16 year old Carmel NY female whose name is being withheld due to her eligibility for Youthful Offender Status, whom are both charged with Petit Larceny, a Class A Misdemeanor.

According to police on December 14th 2015 at 2:18pm a call was received from Sears Security reporting two shoplifters in custody. Officers Rohr and Fortunato were dispatched to the scene and following an investigation at the scene, arrested Lucas Rodriguez and the 16 year old female after they allegedly exited Sears without attempting to pay for assorted clothing, jewelry and perfume valued at total of \$124.99.

Following processing at police headquarters on the aforementioned charge, Rodriguez was arraigned by the Honorable Judge Raniolo. He was remanded to the Westchester County Department of Corrections in lieu of \$1500 cash bail or \$2500 bond and is due to appear in the Yorktown Justice Court on December 17, 2015 at 6pm. The 16 year old female was released to a parent on her own recognizance and is due to appear in the Yorktown Justice Court on January 19, 2016 at 6pm.
