Narrative:

Yorktown Police report the arrest of Maribel Flores-Susano of 421 Dyckman St., Peekskill, New York, who is charged with Leaving an Unattended Dog Confined in a Motor Vehicle, a Town Code Violation.

On Saturday, May 28, 2015 at about 4:30 pm, P.O. Caprio and Det. Shanahan responded to the Sears parking lot located at 600 Lee Blvd. for a report of an unattended dog left in a vehicle. Upon arrival, officers located a small Shih Zhu dog inside a parked, unattended vehicle in the parking lot. At the time of the officers' arrival, the ambient air temperature was 92 degrees Fahrenheit and the Heat Index was 105 degrees Fahrenheit. The officers found the dog without water, panting heavily and wearing a dog sweater. The officers were able to enter the vehicle, remove the dog and place it into an air conditioned police vehicle. It was subsequently transported to Yorktown Police Headquarters where it was given food and water. Officers later located the dog's owner, Maribel Flores-Susano, who responded to police headquarters. It is alleged that Flores-Susano endangered the health and well-being of the dog by allegedly leaving it unattended in the parked vehicle.

The defendant was issued an appearance ticket at police headquarters and is scheduled to appear in Yorktown Justice Court on June 14, 2016 at 6:00 pm.
