TERMS AND CONDITIONS

- The Toormina Gardens 'Colouring In Competition' Promotion (Promotion) commences at 9:00am on Monday 11 April 2016 and concludes at 5:00pm on Friday 22 April 2016 (Promotion Period). The Promotion is promoted by Vicinity Custodian Pty Ltd ACN 077 870 243 in its capacity as trustee for VCX Property Management Trust ABN 21 969 875 489 (Promoter) of Toormina Gardens Shopping Centre, 5 Toormina Road, Toormina NSW 2452 (Toormina Gardens).
- 2. All entrants will be subject to, and will need to adhere to, the Terms and Conditions as set out by the Promoter and any future Terms and Conditions or alterations to these terms and conditions.

PRIZE

3. The prize pool has a total value of \$145 and consists of five (5) x Spalding NBA Grip Control Basketball, valued at \$29 each.

HOW TO ENTER

- 4. To enter the 'Colouring In Competition' promotion a guardian will need to either download a colouring in form from www.toorminagardens.com.au or collect a form from outside Kmart within the promotion period.
- 5. Entry is open to all Primary School aged children. Parent or Guardian consent must be given before each entry is lodged.
- 6. The entrant will need to colour in the form and complete the details on the back in full.
- 7. The form must then be entered into the barrel located outside Kmart within the promotion period.

THE DRAW

In such case, the

first valid entry drawn in the re-draw will be entitled to the Prize (**Replacement Winner**). The Replacement Winner is then a Winner for the purposes of these terms and conditions.

GENERAL CONDITIONS OF ENTRY:

- 13. No responsibility will be accepted for late, lost, incomplete or misdirected entries. Entries which contain incorrect contact details shall be deemed invalid. The Promoter reserves the right in its sole discretion to disqualify any entrant who the Promoter has reason to believe has breached any of these conditions, or engaged in unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of the Promotion.
