

**REMOTE L.A. AUDIENCE AGREEMENT AND WAIVER OF LIABILITY**

Thank you for purchasing tickets to Remote L.A. (the "Production") presented by Center Theatre group and created by Rimini Apparat GbR (collectively, the "Producers"). The Production is a pedestrian-based live art experience that takes place on the street and sidewalks of Los Angeles. In order to participate in the Production, you must sign below indicating your agreement to each of the following terms including the waiver of liability.

**In consideration for being permitted to participate in the Production, you herby represent, warrant, acknowledge and agree that:**

1. You have been loaned headphones for the sole purpose of participating in the Production, and the headphones will remain the sole property of the Producers. The headphones must be returned to Center Theatre Group immediately after the conclusion of the Production, in the same condition as when loaned to you. You will be responsible for the full costs of repairing or replacing the headphones if they are damaged, lost, or stolen while loaned to you, in which case Center Theatre Group will charge your credit card on file up to \$100.
2. You have no health condition that could adversely affect or preclude your participation in the Production.
3. While participating in the Production, you will comply with all applicable laws and regulations and will obey all traffic and pedestrian signals and signage. You will exercise due care when traveling around the city and will remain aware of your surroundings at all times.
4. The Producers do not make any representations or warranties regarding the safety of the Production and you assume all risk from your participation. The Production will involve risks inherent in traveling in and around busy city streets used by vehicular traffic, including, without limitation, the risk of serious and permanent physical injury or death. The price to participate in the Production is non-refundable and in no event shall you be reimbursed for your non-participation in the Production, whether in whole or in part.
5. You release and discharge the Producers, their affiliates and their respective trustees, officers, employees, agents, representatives, and assigns (collectively, the "Releasees") from any and all liability or responsibility for any personal or bodily injury (including death), and for any damage to or loss

of property, however caused, that you suffer as a result of, or in connection with, your participation in the Production, including, without being limited to, any injury, loss or damage resulting from, arising out of, or occurring in connection with the negligent acts or omissions of the Releasees.

6. You will not raise any claim or institute any legal action or proceeding against the Releasees from any cause of action that may result from or arise out of or in connection your participation in the Production, including, without being limited to, any cause of action that may result from or arise out of or in connection with the negligent acts or omissions of any of the Releasees.
7. This agreement and all matters arising out of or relating to this Agreement will be governed by and construed in accordance with the laws of the State of California will have exclusive jurisdiction over the parties with respect to all matters arising out of or relating to this Agreement.
8. I acknowledge that the Producers are the sole owner of the Production, and all rights (including without limitation copyrights) contained therein. I shall not copy, record, photograph, recreate, or otherwise reproduce the Production or any element thereof. I hereby grant Center Theatre Group the absolute right and permission to copyright and use, re-use, publish and re-publish audio, video, and photographic portraits or pictures and may be included, in whole or in part, without restriction as to changes or alterations from time to time, or reproductions thereof in color or otherwise made through any media for art, advertising, trade, or any other purpose whatsoever. I hereby waive any to inspect or approve the finished product or products or the advertising copy, printed matter, audio recordings or video footage that may be used in connection therewith or the use to which it maybe be applied.
