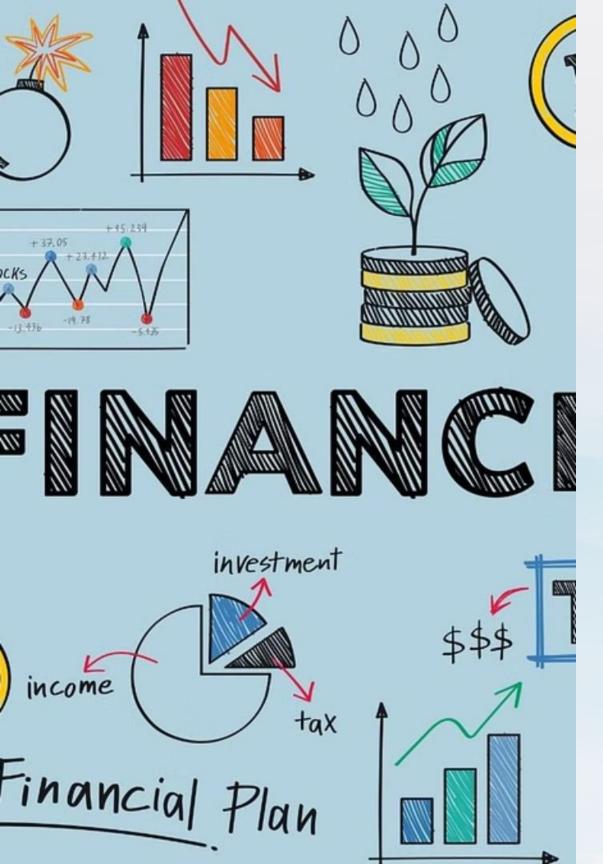

6.3%, outperforming peers' average of 2.9%.

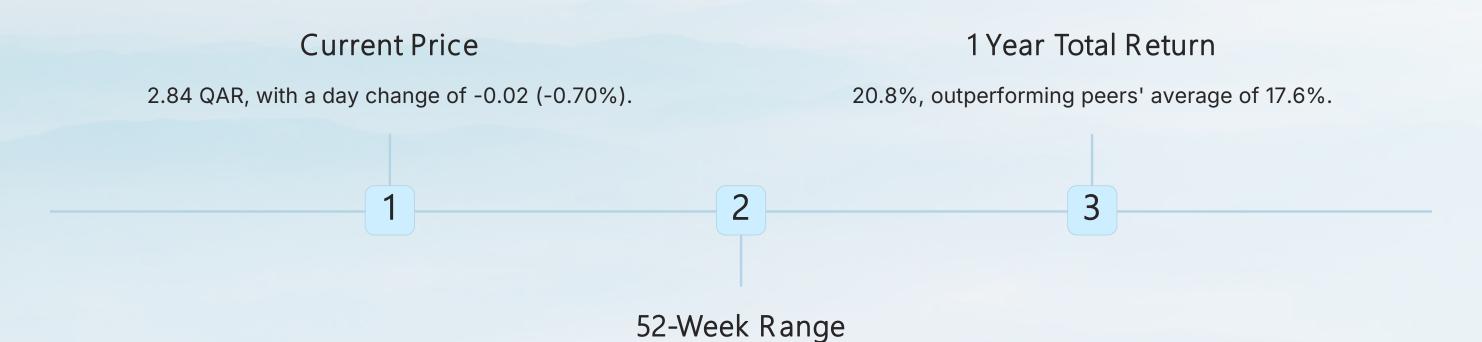
3 P/E Ratio

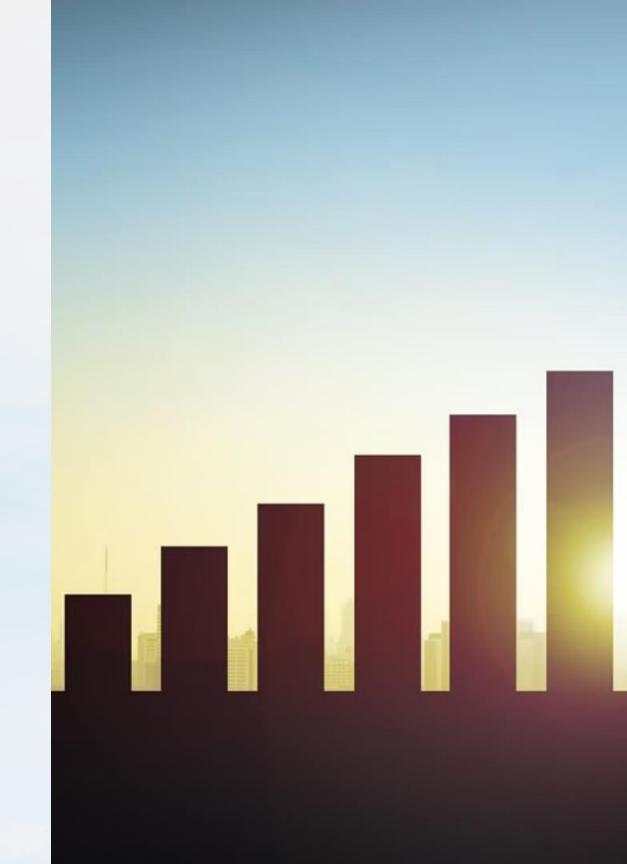
