Potential Health Effects

In poisoned birds, small doses cause involuntary contractions, resulting in distress calls which frighten away others. In rats, dogs and horses, the symptoms of intoxication include hyperexcitability, salivation and tremors progressing to clonic and tonic convulsions. The active ingredient has a strong excitability effect on the central nervous system, probably by enhancing cholinergic transmission.

The acute effects on humans is not reported. However, it is likely to cause distress if taken in large quantities. It is unlikely to cause major problems if used in the intended manner. Read labels carefully *prior* to use.
