

PLAYER RELEASE, DISCHARGE, WAIVER AND COVENANT NOT TO SUE

Player: _____ (includes all players attending an Event, and each of their respective representatives, executors, administrators, heirs, next of kin and assigns) ("Player")

Event: Nacogdoches Team Pickleball League ("NAC TPL") (includes all matches, tournaments, and meetings related to the Event)

In consideration of participation in the Event, and by their signature below, Player agrees:

PLAYER ASSUMES RISK. Player is aware of and understands the inherent risks and dangers of the Event and the potential for injury that exists when participating in the Event, and agrees to assume all risk of and responsibility for personal injury or death, or damage to or loss of property of the Player arising from, based upon, or relating to the Player's participation in the Event. Such assumption of risk includes, but is not limited to, any personal injury or death, or damage to or loss of property, arising from, based upon or relating to the lack of skill, improper conduct, and/or the acts or omissions of any Player or Released Party, caused in whole or in part by the negligence of any Released Party.

RELEASE FROM LIABILITY AND COVENANT NOT TO SUE. Player hereby voluntarily agrees to and does hereby release and forever discharge, and agrees not to sue, all other participants in NAC TPL, including but not limited to Commissioners, Captains, and other Players (collectively, the "Released Parties"), for any and all liabilities, losses, damages, costs, expenses (including, but not limited to, attorneys' fees and expenses), causes of action, suits and claims of any nature whatsoever (collectively, the "Liabilities") arising from, based upon, or relating to personal injury or death, or damage to or loss of property of, the Player sustained in connection with the Player's participation in the Event or travel to or from the Event. Such Release shall include but not be limited to any and all Liabilities caused in whole or in part by the negligence of any Released Party in connection with the Event.

RIGHT OF PUBLICITY. Participation in the Event shall constitute permission to use the name, image, voice, words, likeness, or any other identification of the Player for advertising, publicity, or any other reasonable purposes in connection with the Event without compensation to or right of prior review or approval by the Player. The Player agrees, for itself and its personal representatives, executors, administrators, heirs, next of kin and assigns, to release and discharge, and to not sue, the Released Parties for, any and all Liabilities arising from, based upon or relating to any claim for invasion of privacy, violation of right of publicity, defamation, appropriation, or similar claim, in connection with such use.

MISCELLANEOUS. If any portion of this Release shall be held invalid or unenforceable, the remaining portion shall remain in full force and effect. This Release is governed by Texas law, and venue and jurisdiction for any action or suit related to it shall be exclusively in Nacogdoches County, Texas.
