## **Rules and Regulations**

- 1. Vendors must be 18 years of age or older.
- 2. Incomplete vendor applications will not be accepted.
- 3. Vendors may only sell the items that were approved with their application. If non-approved items are displayed for sale, vendors will be asked to remove these items.
- 4. Vendors are required to stay for all hours of the event, and to be on time. Early departing vendors and those who do not exhibit all hours of event will not be accepted at future events.
- 5. Display booths and area must be kept clean and neat at all times. All packing boxes, supplies, and personal items must be hidden from public view. The vendor booth and area must be left clean at the end of the day.
- 6. Electrical outlets may only be used if the appropriate fee is paid. Electrical is on a first-come first-serve basis. The fee is \$10.
- 7. Vendors must supply their own displays, chairs, tables, props, and coverings.
- 8. No Alcoholic beverages are allowed.
- 9. Vendors may not display or distribute any information outside of their designated booth(s). Any violators will be asked to leave.
- 10. Vendors must supply a raffle item with a minimum \$25 value. Vendors must bring their raffle item to the event on September 9th to the raffle table.
