From Jack's Desk

Jack Sutton, Chief Executive Officer

For many years, area leaders and the general public have encouraged Great Parks to work cooperatively with nonprofit organizations, private sector entities and other public sector agencies to further our mission in Hamilton County. This is certainly appropriate advice, as we have continued to hear similar comments during our Comprehensive Master Plan project. But did you know, Great Parks has been "walking this talk" for decades? I recently was reminded of a "partnership" that began nearly 50 years ago that is still reaping benefits today.





Since 1971, Great Parks of Hamilton County (then known as Hamilton County Park District)

and The Nature Conservancy (TNC) joined forces to preserve unique natural areas in the Cincinnati-Hamilton County area. The Nature Conservancy was – and still is – a leading conservation organization working around the world to protect ecologically important land and water resources. TNC has helped to protect more than 119 million acres of land and conserve thousands of river miles and more than 100 marine projects across the globe.

The following acquisition stories attest to the successful and significant accomplishments realized when a major regional park system and an international organization dedicated to preservation of natural areas work together.

Winton Woods – A 33-acre tract formerly known as Spring Beauty Dell was acquired by TNC in 1971. While being held by TNC, the acquisition was used as a basis for a successful grant resulting in the development of a picnic complex in the McKelvey Road area. Now known as the Warren Wells Preserve, this 33-acre tract was considered one of the finest examples of Beech-Maple climax forest in our geographical area when it was acquired. Today, Winton Woods includes 2,555 acres.

Embshoff Woods – An initial donation of 40 acres was made to TNC in 1974 by George and Margaret Embshoff, avid conservationists and Delhi Township residents. Working with the park district, TNC was instrumental in the acquisi-

tion of an additional 94 acres by 1979. Embshoff opened to the public in 1982, and now consists of 334 acres of protected green space.

Woodland Mound – In 1977, TNC assisted in the acquisition of five tracts totaling 89 acres, including a gift of 40 acres of mature woods, representative of the Eastern Deciduous Forest, from Mrs. Sara K. Weston. Today, Woodland Mound encompasses 1,070 acres.

Withrow Nature Preserve – The initial purchase of 141 acres was negotiated by TNC in 1977. Mr. and Mrs. Eugene Farny donated 127 acres, contiguous to the original purchase, to TNC for eventual transfer to the park district in 1981. Today, Withrow Nature Preserve includes 270 acres.

Richardson Forest Preserve – The Nature Conservancy assisted in acquiring a 162-acre gift from Mrs. Ann W. Richardson in 1978 in memory of her late husband, Dr. Albert S. Richardson. The gift acreage was used to leverage matching grants in order to acquire additional adjacent forested land. Mrs. Richardson donated the land because of her desire to see it preserved in a natural state and her keen interest in youth education. Today, Richardson Forest Preserve protects 393 acres.

Kroger Hills – This conservation area consists of 217 acres, 89 of which were used as a federal grant application match by the Ohio Department of Natural Resources (ODNR), and held for a time by TNC. Great Parks has protected this land through a long-term lease with ODNR since 1978.
