

## PRIVATE DRONE APPLICATION FORM

Private drone users are required to complete a drone application. Please provide application at least two weeks prior to requested fly date.

## **Drone Usage Regulations**

- The drone policy is nontransferable and an approval letter must be in possession while on park property.
- Drone owner must follow all Federal Aviation Administration (FAA) guidelines for Unmanned Aircraft Systems and Great Parks of Hamilton County bylaws.
- The holder of the approval letter is liable for any damage to park property.
- No vehicles are permitted on grass, sidewalks or other park areas not designated as vehicle parking areas.
- No flying is permitted in nature/wildlife management areas, over people, over animals at Parky's Farm and Winton Woods Riding Center or areas not open to the public.
- Great Parks reserves the right to revoke drone approval at its sole discretion.
- Any misuse of park property or failure to comply with Great Parks of Hamilton County bylaws will result in revocation of drone flying approval and possible expulsion from the property.
- Park visitors are not to be prevented from using park facilities and amenities as a result of drone flying. Drone photos or video must not include any park visitors without their prior permission.
- A valid Motor Vehicle Permit is required to enter the parks. Cost for residents of Hamilton County: \$10 annual/\$5 daily; other visitors: \$15 annual/\$8 daily. Otto Armleder Memorial Park and Fernbank Park are cooperative ventures with the City of Cincinnati; a Motor Vehicle Permit is not required.
