Juried Show  
Monterey County 3-Dimensional Diorama “Grab Life by the Moments”



**OVERVIEW**

In cooperation with the Monterey County Convention & Visitors Bureau and County of Monterey Economic Development, the Arts Council is seeking a team of artists, who will create a 3-Dimensional diorama for a glass showcase built into the wall (inside measurements are 63”x46”x22,5”). The winning design will be placed on a display at the Capitol building in Sacramento. The winning team will capture the essence of Monterey County as it evokes a sense of this year’s theme “Grab Life by the Moments” and encourages viewers to visit our county. The display will remain in the Monterey County glass showcase, in the halls of the California Capitol, for one year, insured for up to \$4000. **WINNER RECEIVES**

Total \$2,500 (\$1000 prize plus \$1000 for materials plus \$500 installation fee)  
*(\$\$ awarded to the lead artist, and the lead artist will distribute it among team members)*  
Recognition for the achievement (press releases, ACMC newsletter/website)  
Complimentary Invitation (up to 4) to the reception in Monterey

**ELIGIBILITY**

Including painting, sketching, photographs, sculptures – designed for a 3-Dimensional diorama to be displayed inside a glass showcase – which represents the essence of Monterey County and a sense of this year’s theme “Grab Life by the Moments,” thereby encouraging viewers to visit our county.

**RULES**

Include original works only (i.e., no copyrighted material)  
Not commercial in nature  
Represent the work of more than one artist  
Design must include our four economic pillars; tourism, agriculture, education and research.  
Design must harmoniously fit the available space (63”h x 46”w x 22.5”d)  
For technical details, see attached technical drawing of the glass showcase and SAM description  
Winning team is chosen according to subject matter, originality and craftsmanship  
(Arts Council staff and board members are not eligible to enter)  
All decisions are final.

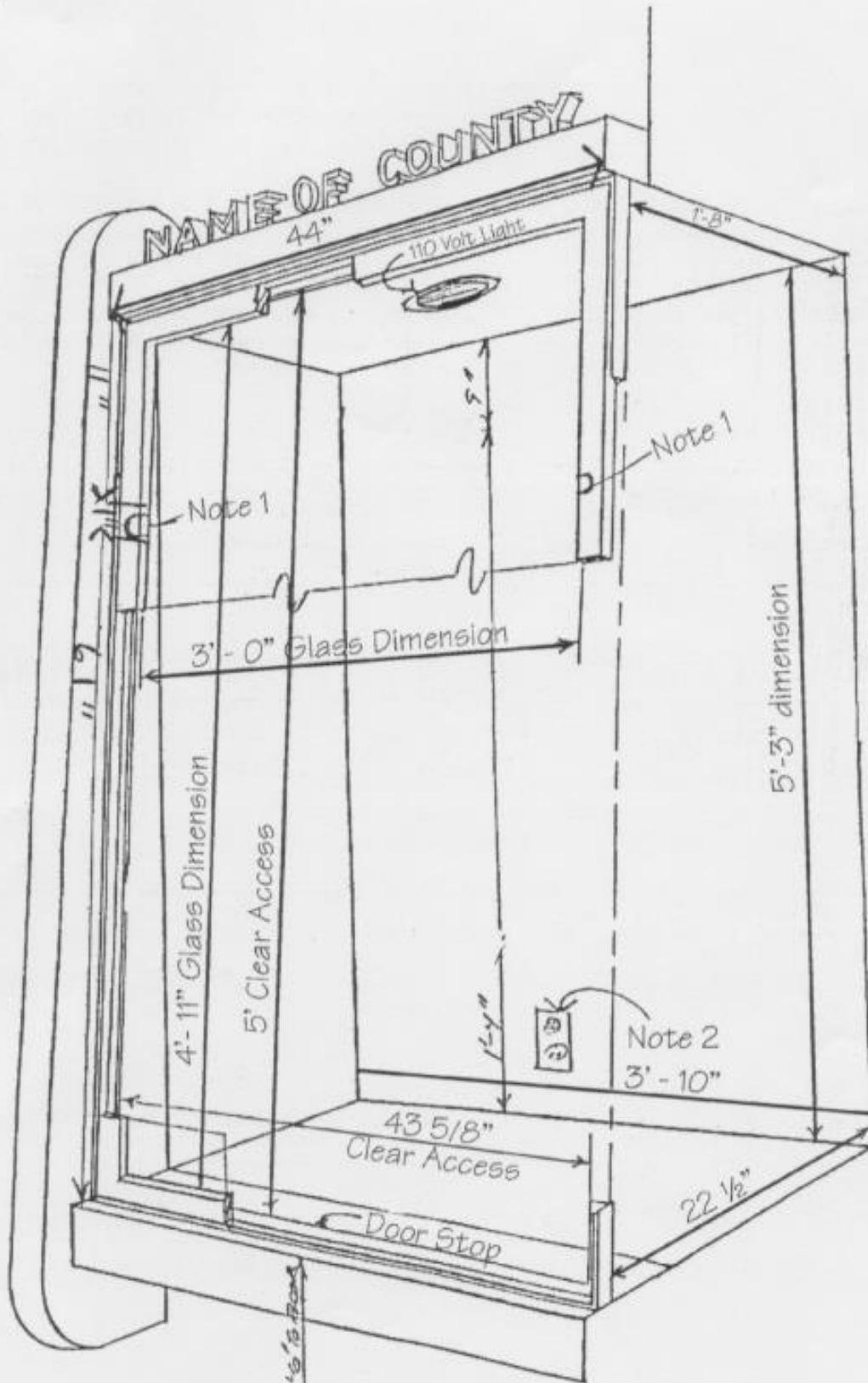

### **1330.7 DISPLAY OF ART, POSTERS, AND NOTICES IN STATE BUILDINGS**

(New 3/00)

Posting signs, notices, or other written material in DGS-owned and managed office buildings is not allowed except on bulletin boards or other display equipment designed for this purpose. This policy is designed to prevent damage to painted surfaces and maintain a clear entry and exit. Commercial or political notices are not permitted. Artwork displayed in lobby areas will be shown only with the approval of the Director of DGS. The Director will designate a location and duration for display. If you plan a display, your justification should follow these guidelines:

1. Display will include work by more than one artist.
2. Display is not controversial.
3. Display is not commercial and/or not for sale.
4. State will not be liable for damaged or stolen artwork.
