PROVIDENCE, RI: **Trinity Repertory Company** is pleased to announce plans to offer **open captioned and American Sign Language (ASL) interpreted performances during the upcoming 2011-2012 season**. The state-of-the-art technology will allow Trinity Rep to continue in its mission of providing theater access to a wider community by making performances accessible to patrons with hearing loss. **Open captioning seats are available for \$22, and an open captioning subscription is also available for \$66. "We are absolutely thrilled to work with such generous partners who have continued to make Open Captioning possible for another season," states Trinity Rep's Artistic Director **Curt Columbus**. "We are always looking for ways to ensure that the incomparable experience of live theater is something that is available to all audiences, regardless of traditional barriers."

The schedule for open captioned performances in the 2011-2012 Season is as follows:

***His Girl Friday*, Sunday, October 9, 2011 at 2:00PM, Chace Theater; *Clybourne Park*, Wednesday, November 9, 2011 at 2:00PM, Dowling Theater; and *A Christmas Carol*, Sunday, December 4, 2011 at 12:00PM, Chace Theater. There will also be an ASL-interpreted performance of *A Christmas Carol* on Sunday November 27, 2011 at 12:00PM.**

Open Captioning is a general term used to describe text displayed simultaneous to live speech, dialogue or performance. As opposed to closed captioning, open captions do not require the user to have any special equipment for viewing the text and are always "open" to anyone.

Trinity Rep's open captioning is provided by **c2**, the pioneer of Live Performance Captioning for hard of hearing and deaf patrons at live theatrical and cultural events. c2 is internationally recognized as the leading authority in the field. Their mission is to expand services throughout the United States. c2 boasts an impressive roster of prestigious venues now offering this vital access program.

Trinity Rep is fully handicapped accessible, with elevator service to the Chace Theater. State-of-the-art infrared Assistive Listening Devices (ALDs) are available for all performances in the Chace and Dowling Theaters. Support for Trinity Rep's accessibility programs comes from the Rhode Island State Council on the Arts, with additional support from the Vigneron Memorial Fund, Bank of America N.A., Trustee.
