Carol Chorbajian reported on the Community Relations Committee meeting. The new Marina Marriott Springhill Suites is scheduled to open in May/June. Tammy added that MCCVB staff did mid-year presentations to the city councils of Carmel, Marina, and Pacific Grove in March. Mid-year presentations are scheduled for the cities of Monterey, Salinas, and Seaside the third week of April. Rick and Mayor Rubio reported that the new In-N-Out restaurant opened to huge crowds.
