It was suggested by Norm Krug that at the next meeting the Board looks at the possibility of a loan if needed to cover initial marketing expenditures based on cash flow once the reimbursement costs are known.

Linda Kelly let the Board know the City of Sonoma will need documentation to show the STID Corporation is a non-profit and is registered with the Secretary of State prior to disbursement of funds.

Wendy Peterson did a marketing presentation which included a marketing timeline and showed the new Winery Map with Lodging payers listed on the back and the new billboard art on Highway 37

How STID exemptions are handled was discussed and it was agreed that Norm Krug and Dan Parks will meet with the City of Sonoma to review and approve any exemptions with the right to request back up information from the properties if needed. Dan Parks, Byron Jones and Bill Blum agreed to work on an exemption policy to review at the next meeting.
