## Tyler Perry Announces Additional Cities for Final Madea Stage Play Tour “Madea’s Farewell Play Tour” comes to DeVos Performance Hall March 5-6

**Grand Rapids** — Yesterday actor, playwright, filmmaker, and comedian, **Tyler Perry**, has announced the second round of dates for **Tyler Perry’s “Madea’s Farewell Play Tour”**. The nationwide tour will kick off in Oakland, CA on January 18 before Perry brings his beloved characters to Grand Rapids for two shows at SMG-managed **DeVos Performance Hall March 5-6, 2019 at 7:00 PM**.
