Call to Order: The meeting was called to order at 7:33 a.m. by Jennifer Furst.

Approval of Meeting Minutes:

It was moved and seconded to approve the June 26, 2019 meeting minutes. Motion carried.

Davis Park Presentation:

- The board was reminded that nearly one year ago John Groh was asked to chair the mayorappointed taskforce to determine best use of Davis Park. The taskforce is to make recommendations for the operation, amenities and future of the park, including the Lorden building.
- Angela Larson noted that a key question of who will take on the long-term oversight and management of the park remains. A subcommittee, that she chaired, has recommended that RACVB be assigned the responsibility of managing, operating and programming the park.
- Mayor Thomas McNamara thanked the board for their dedication and discussed that Davis Park is the only city-owned park in Rockford and a priority for his administration. During his remarks, he asked the board to consider taking on the responsibility of managing, operating and programming the park. As such, he noted that he fully supports the subcommittee recommendation and believes that RACVB would be successful managing/operating/programming the park due to extensive experience.
- Jennifer Furst will appoint a taskforce of board members and stakeholders to analyze the opportunity and make a recommendation to the board.

Internal Monitoring Reports:

After discussion, it was moved and seconded to accept the report Internal Monitoring Reports 2.3 and 2.4 as submitted, including John's CEO interpretations. Motion carried. Keven Frost abstained.

CEO Report:

- Davis Park Summer Series underway with Workout Wednesdays and Music at Davis Park on Thursdays.
- Nick Povalitis was congratulated for his CDME graduation by John Groh and Mayor McNamara.
- Tana Vettore received a "Challenge Coin" from Mayor McNamara and thanked for going above and beyond, working towards a yes and caring about the city.
- Business is Blooming press conference and announcement of winners is scheduled for August 1.

- Jehovah Witness Convention continues with 4 weeks this year.
- Winnebago County showed a 2% positive economic growth rate for a total of \$391 million. The growth is below the state average but higher than our direct competitors.

- Board orientation schedule for Aug 1 will be postponed due to availability.
