The West Haven resident serves as House Chair of the Bonding Subcommittee and works with legislators across Connecticut to support tourist venues through Capitol support. Rep. Borer also is a member of the Legislature's Banking and Public Safety Committees, and is Co-Chair of the Women's Bipartisan Legislative Caucus.

**Sen. Jorge Cabrera** is Connecticut's State Senator for Ansonia, Beacon Falls, Bethany, Derby, Woodbridge and parts of Hamden and Naugatuck. He is the Deputy President Pro Tempore of the State Senate and is Chair of the Legislature's Veterans' Affairs Committee, Vice Chair of the Labor & Public Employees, and is a member of the Capitol's Finance, Revenue & Bonding Committee; Human Services Committee; and Insurance & Real Estate Committee. A business representative for UFCW Local 919, the Hamden, Conn. resident has been championing issues for working families in the district and across the country for more than 25 years.

Jan Louise Jones, Ph.D., is a nationally recognized travel and hospitality media consultant who currently serves as the Program Coordinator and full-time Lecturer of Hospitality & Tourism Management in the Pompea College of Business at the University of New Haven. She has more than 10 years of teaching and curriculum development experience in the areas of sustainable tourism management, hospitality, event management and

recreation/leisure studies. Dr. Jones has spent the last 20 years conducting research, serving in international scientific committees and presenting in over 17 countries about the importance of sustainable tourism development and management. She is contacted by media on a regular basis for her analysis and evaluation of current trends and issues related to tourism and hospitality industries.

Cian Stein has been a champion of Downtown Bridgeport and the development of the Harbor Yard Entertainment area for nearly two decades. He is the Executive Vice President of the exciting new Hartford Healthcare Amphitheater that is located next to the Total Mortgage Arena (formerly called the Webster Bank Arena). Previously, as Senior Vice President of Sales & Corporate Partnerships for Harbor Yard Sports and Entertainment, he oversaw the sales and marketing divisions for both the Arena and Bridgeport Sound Tigers, now the Bridgeport Islanders. The Fairfield, Conn. resident has worked closely with the Connecticut Convention & Sports Bureau for years to generate new and returning sports events business for Fairfield County.
