Stroll on State security plan was discussed. Overall plan is formatted and operated by the City of Rockford Police with additional private and volunteer security in place.

A grant request was submitted to the State for \$235,000 for the expansion of CRE8IV: Transformational Arts. Marketing Partnership grant is still pending.

Tiana McCall was congratulated on being elected to the RPS School Board.

Partner Updates:

Pat Thompson reported that there is no levy increase or increase for River Bluff. The Stroll on State grant request is before the full board at tonight's meeting.

Todd Cagnoni reported that the removal of the Lorden building is in progress. The FY23 budget was approved and also includes a flat levy and no increase.
