

LEGISLATIVE UPDATE

This week saw a lot of filibustering in the Missouri Senate, with the session ending tomorrow. The House of Representatives briefly convened this morning and are in recess until 2:00 p.m. The Senate is in session attempting to get more bills through.

Nearly 900 bills were filed in the Senate and more than 1400 in the House this session. Below is a list of all non-budget bills that have been passed, as of noon today. Note, several amendments have been placed on some of these bills. That will continue as legislators attempt to get their priorities approved this session.

- Creates the "Missouri First Responder Mental Health Initiative Act" SB 28 Brown, Dist. 16, Rolla
- Modifies provisions relating to access to public records of the Missouri Highway Patrol SB 39 Thompson, Dist. 27, Sikeston
- Establishes guidelines for student participation in athletic contests organized by sex SB 49 Moon, Dist. 29, Lawrence County
- Establishes the "MO Save Adolescents from Experimentation (SAFE) Act" and modifies provisions relating to public funding of certain gender transition procedures

- Related to physical therapists

SB 70 Fitzwater, Dist. 10, Holts Summit

Related to professional licensing (health care)

SB 75 Black, Dist. 12, Chillicothe

- Retirement systems

Show MO Act and Entertainment Industry Jobs Act

SB 101 Crawford, Dist. 28, Buffalo

- Enacts provisions relating to property and casualty insurance (Privatization of public corporations, aircraft insurance, lender-placed)

- Related to public health (Patient exams, extends MO Health Net benefits for pregnant and postpartum women, and several other provisions)

SB 167 Brown, Dist. 26, Washington

- Related to medical examiner's certificate

SB 190 Luetkemeyer, Dist. 34, Kansas City

- Tax relief for seniors (Property tax credit and retirement benefits income tax deduction)

SCR 8 Bean, Dist. 25, Holcomb

- Designates Campbell as the Peach Capital of Missouri

HB 131 Griffith, Dist.

- Allows for payment of state employees every two weeks

HB 402 Henderson, Dist. 117, Bonne Terre

Modifies provisions related to health care

HB 417 Henderson, Dist. 117, Bonne Terre

- Grants to employers for upskilling employees

HB 202 Francis, Dist. 145, Perryvillie

Repeals industrial hemp regulatory program

The Department of Economic Development (DED) has posted final guidelines for its Nonprofit Grant Program. The program is funded via the State of Missouri's share of the American Rescue Plan Act (ARPA). This program will invest \$7.5 million to support 501(c)(3) and 501(c)(19) nonprofits serving disadvantaged, vulnerable, or at-risk populations that have experienced negative economic impact due to the COVID-19 pandemic.


Applications are expected to open May 31 at 10 a.m. CDT. Complete information is also available on DED's ARPA Business and Community Development webpage.
