Call to Order: The meeting was called to order at 7:34 a.m. by Carol Schuster.

Governance Process:

Board Self-Assessment Report/Discussion:

Bill Geist shared the results of the Board Self-Assessment, which included an online survey and one-onone conversations between board members and Bill. During his comments, Bill noted that the organization is to be commended for building a strong governing Board, for being increasingly inclusionary as the organization broadens its impact on the region and for desiring to continually improve as evidenced by the self-assessment process.

Opportunities for improvement included enhanced/expanded onboarding/orientation for new members, structuring board meeting agendas to allow for more generative discussions on topics of importance, scheduling board meetings off-site at partner venues to enhance linkages with stakeholders and finding additional ways to utilize board members as ambassadors for the organization in the community.

CEO Report:

Destination Master Plan Update: A project kickoff call was held and parties are working to finalize contract details and setting up online workspaces. Staff is currently thinking through initial stakeholder interveiws and how the community engagement process will unfold. Staff plans to update the board during each regular board meeting and in between as material developments arise. The work will need to be wrapped by June 30, 2024.

CRE8IV 2023: John Groh said that CRE8IV 2023 is moving forward. RACVB received a grant from the state of \$230,000 with an end date of December 31, 2024 to spend the grant. This allows RACVB to do an impactful CRE8IV festival in June 2024. The grant does not fund the murals, but funds the festival and related components. The process is underway to get murals commissioned and installed for 2023.
