"Win your new boat in the Outaouais" contest Rules

Read and accept the rules

1. The "Win your new boat in the Outaouais" contest will be held between April 1st, 2016 and November 1st, 2016. It consists of a random draw among the customers of Outaouais outfitter establishments who meet the contest requirements between the following dates: April 1st, 2016 and November 1st, 2016.

2. This contest is open exclusively to persons 18 years of age and over in Quebec, Canada and the United States.

3. Contestants can participate by filling out an entry form available from the participating Outaouais outfitters. To be eligible, you must be a customer at an Outaouais outfitter and fill out an entry form before November 1st, 2016. The minimum stay is one night in a cabin or an inn. Entry forms are also available at Tourisme Outaouais.

4. As an alternate method of participation, you can send a 50 word paragragh describing a hunting, fishing or family expedition at one of our outfitters. You can send this text by mail to Anne-Marie Charron at: 103 Laurier Street, Gatineau (Québec) J8X 3V8 no later than November 1st, 2016. The postmark will be proof of the date sent. One entry form per contestant.

5. Each participant is entitled to one chance to win. The limit is one contest entry form per customer.

6. The "Grand Prize" consists of a Princecraft Scamper motorboat, a Mercury 9.9, 4 stroke engine and a trailer, for a total value of approximately CDN \$6,000, tax included. This complimentary prize is offered by Équipements Maniwaki. The boat licence plate fees, the insurance fees and the trailer licence plate fees are the winner's responsibility. The prize will be awarded by Tourisme Outaouais on behalf of the Outaouais Outfitters Association. The Grand Prize does not include custom duties of 1% of the value of the boat if the winner is a United States resident. The chances of winning depend on the number of eligible contestants. By accepting the Grand Prize, the winner recognizes the inherent dangers of use of a motorboat and acknowledges that Tourisme Outaouais, the Outaouais Outfitters Association and Équipements Maniwaki are not liable for any injuries, accidents or fatalities.

7. The contestants have up to November 1st, 2016 at 11:59 p.m. to fill in the entry form at a participating outfitter establishment.

8. The prize will be drawn at random by hand among the contestants who have met the contest requirements. This draw will be held on January 10, 2017, at 10:00 a.m., at the Maison du tourisme, 103, rue Laurier, Gatineau, QC J8X 3V8. The winner will be contacted by telephone or by mail. In the event that the winner cannot be reached within 10 days of the draw, another contestant will be chosen.

9. The prize must be accepted as is and may not be transferred, exchanged or substituted.

10. Any persons who, during the contest period, or at the time of the draw, are employees, officers, agents or representatives of Tourisme Outaouais, the Outaouais Outfitters Association and Équipements Maniwaki, as well as persons sharing their domicile, will not be eligible to enter the contest.

11. The contest winner will be notified by telephone and the prize will be set aside at Équipements Maniwaki at 62, Route 105, Maniwaki, Quebec (J9E 3A9) for the winner to take possession before April 1, 2017.

12. By accepting the prize, the winner consents that Tourisme Outaouais, the Outaouais Outfitters Association and Pourvoirie Québec use his/her name, place of domicile and photograph for promotional purposes without additional compensation.

13. Tourisme Outaouais reserves the right to terminate the contest after receiving authorization from the "Régie des alcools, des courses et des jeux" if events beyond its control prevent the contest from continuing. In such a case, they may not be held liable in any way.

14. Any person who wins this contest agrees to abide by these rules and the decisions of Tourisme Outaouais, who administers the contest, and whose decisions are final and not subject to appeal.

Tourisme Outaouais and the persons for whose benefit the contest is held will assume no responsibility of any nature whatsoever in any case where their inability to act results from a fact or situation beyond their control or a strike, a lock-out or any other labour conflict in the establishments of the organizations or enterprises whose services are used to hold this contest.

16. Any dispute regarding the awarding of the prize may be submitted to the "Régie des alcools, des courses et des jeux" for settlement. This dispute may be submitted only for the purposes of an intervention in an attempt to settle the dispute.
