

CONTEST RULES “Bicyclette de Hull / Procycle Aylmer”

The “Bicyclette de Hull / Procycle Aylmer” contest begins on Friday, May 20, 2016.

How to enter

Fill out an online entry form on our website at outaouaistourism.com. As well, Outaouais Tourism will have a booth at each of the following events, and you can fill out an entry form on site:

- 1- Tamarack Ottawa Race Weekend (May 27–29)
- 2- Tour de la Petite-Nation BMR (June 11–12)
- 3- Reebok Spartan Race (June 18–19)
- 4- National Bank One for Youth Bike Tour (July 8–10)
- 5- MSM Mountain Fest (July 24–26)
- 6- Grand Tour Desjardins (August 6–12)

Limit one entry per person per email address per day. Any additional entries from the same source on the same day will be disqualified.

The contest winner agrees to allow his name, age, and place of residence to be disclosed in media announcements (on air and online).

Limit of one (1) entry per individual per email address per day. Any attempt to enter more than once per day will result in immediate disqualification.

No purchase necessary.

All entries become the property of Outaouais Tourism and none will be returned.

2. Eligibility

To enter the contest, participants must be at least 18 years old and must fill out an entry form as described in Section 1 above.

The following are NOT eligible to enter:

Employees, agents and representatives of Outaouais Tourism, of any company, corporation, trust or other legal entity controlled by or affiliated to them, their advertising and promotional agencies, suppliers of prizes, material and services related to this contest, as well as members of their immediate family (brothers, sisters, children, father, mother), their legal or common-law spouse, and any individuals with whom such employees, agents and representatives are domiciled.

3. Prize

The getaway package is for 2 people and includes:

- ❖ Registration for the 2017 cycling event of your choice: Grand Prix Cycliste Gatineau, BMR Tour de la Petite-Nation or Vélo MSM Mountain Fest
- ❖ 2 room nights, double occupancy
- ❖ Admission to Nordik Spa-Nature to soothe those aching muscles
- ❖ A Miele Preza XD hybrid bicycle (retail value \$600) donated by Bicyclette de Hull and Procycle Aylmer

Prize package does not include: Transportation and meal expenses (other than those specified above), beverages, gratuities, and personal expenses.

The approximate total value of the contest prize (depending on the challenge selected) is eight hundred dollars (\$1000) before taxes.

The prize must be accepted as awarded. It may not be substituted for another prize or exchanged in whole or in part for cash and/or be transferred to another person.

4. Draw (Selection of Winner)

One (1) entry form will be drawn at random among all ballots entered in accordance with the contest rules, on October 10 approximately 11:00 a.m., at the Outaouais Tourism office located at 103 Laurier Street in Gatineau.

To be declared the winner, the selected entrant must be 18 or older, and must have completed a written entry form, correctly answered the mathematical skill-testing question, and complied with all other contest requirements specified in this document, failing which he will be disqualified and another draw will be held, in keeping with these contest rules, until another entrant is selected and declared the winner.

The selected entrant will be contacted by telephone within two (2) business days following the draw date, and informed of the procedure to follow to claim the prize. Once contacted, the entrant will be sent a Declaration and Release Form (the "Declaration Form") described in Section 5.2 below for signature. As well, the entrant must provide the name of the guest (1) accompanying him (sharing the prize package), and have that person sign the Declaration Form.

Outaouais Tourism cannot be held responsible in the event contest organizers are unable to contact a selected entrant.

The selected entrant will have seven (7) business days following the date of telephone contact to claim the prize and return the completed, signed Declaration Form to Outaouais Tourism. If a selected entrant cannot be contacted by Outaouais Tourism within two (2) business days following the draw, does not claim the prize within seven (7) days of telephone contact, fails to return the signed Declaration Form within the allotted time, and/or is otherwise not in compliance with the contest rules, he will be disqualified and forfeit his opportunity to be declared a winner. In such a case, Outouais Tourism will hold another draw, in keeping with these contest rules, until another entrant is selected and declared a winner.

- 5.2 The contest winner releases and holds harmless Outaouais Tourism, any company, corporation, trust or other legal entity controlled by or affiliated to them, their advertising and promotional agencies, suppliers and sponsors of material and services related to this contest, and their employees, agents and representatives (the "Released Parties") from and against any damage resulting from participation in this contest, from the acceptance or use of the prize. or from the use of services related to the prize. The contest winner and his guest agree to sign a Declaration and Release Form (the "Declaration Form") in favour of the Released Parties, confirming their acceptance of these contest rules and of the prize as awarded, and releasing and holding harmless the Released Parties as specified above. If the winner's guest is under 18 years of age, a parent or legal guardian must complete and sign the Declaration Form on the guest's behalf.
- 5.3 The winner understands and acknowledges that the Released Parties make no warranty, guarantee or representation of any kind concerning the prize and disclaim any implied warranties.
- 5.4 The winner authorizes the contest organizers to use his name, photograph, likeness, voice, place of residence, prize statement or presence for publicity purposes, if required, without restriction as to time, medium or place, and without any form of remuneration.
- 5.5 If the winner declines the prize, the Released Parties are released from all responsibility and obligation with respect to the winner.
- 5.6 Outaouais Tourism reserves the right, at its sole discretion, to cancel, end, modify or suspend this contest, subject to the approval of the Régie des alcools, des courses et des jeux du Québec, if required.
- 5.7 The Released Parties do not warrant that access to or use of any contest website will be uninterrupted or error-free, and disclaim all liability for any problem that may limit or prevent any entrant's participation in the contest, including but not

- limited to: a technical failure with the telephone network, telephone lines, on-line computer systems, servers or providers, computer equipment, or software, or a failure in any transmission (including email) to Outaouais Tourism for any reason including but not limited to congestion on the Internet network or on an Internet site or the combination of the two. The Released Parties will not be held responsible for any damage that could affect the computer equipment of participants following their registration in the contest.
- 5.8 The Released Parties assume no responsibility for losses, delays, address errors, printing errors, or any other error related to this contest.
- 5.9 The Released Parties will assume no responsibility whatsoever in the event that they are unable to act because of situations or circumstances beyond their control, including but not limited to a strike, lockout or any other labour dispute occurring in the places of business of the organizations or companies whose services are retained to hold this contest.
- 5.10 Personal information collected for purposes of the contest will be used by Outaouais Tourism or its authorized representative only to administer the contest, and will not be used for any other purpose without the express consent of the participant or his parent, guardian or legally authorized representative. By providing this information, the entrant consents to its being used for the stated purposes.
- 5.11 Any dispute regarding the organization or conduct of a publicity contest may be submitted to the Régie des alcools, des courses et des jeux du Québec for a ruling. Any disagreement regarding the awarding of a prize may be submitted to the Régie only for the purpose of an intervention to attempt to resolve such disagreement.
- 5.12 In the event of the unavailability of the advertised prize because of circumstances beyond their control, the Released Parties reserve the exclusive right, at their sole discretion, to award a prize of the same kind and of equivalent value, without right of appeal by the winner.
