## Waiver of Liability

§ 1 Aware of the risks incurred by attending a motor sport event, I vouch to strictly and immediately obey the rules and instructions (written, oral, and visual) issued by the event hosts, ADAC Motorsport, the Stewards of the Meeting/Race Directors, the officials, the police, or any of their agents, including but not limited to keeping out of restricted areas and safety lanes.

§ 2 I agree that I shall act at my own risk by leaving the general spectator areas or the areas the Stewards of the Meeting/Race Directors specifically assigned to me, including any areas not so designated but where the event hosts may tolerate my presence:

- designated spectator areas,
- the paddock and access/connecting lanes,
- the pit area.

I am also aware that it is generally prohibited to step outside the track boundaries (crash rails, concrete elements etc.).

§ 3 On my own behalf and that of my dependents, I waive my right to claim damages for injuries, damage or financial loss incurred while being outside the general spectator areas or the areas specifically assigned me by the Stewards of the Meeting/Race Directors, provided that such accident and injury/damage was not the result of any intentional or grossly negligent act by the group of persons below. Such waiver shall apply to:

- FIA, ADAC e. V., the DMSB, their presidents, secretaries general, members, volunteers and employees;
- ADAC local and regional clubs;
- event hosts, their agents, officials and assistants;
- race-track owners and their agents;
- the drivers, co-drivers, owners or registered keepers of vehicles, the entrants and their agents in connection with races, special stages designed to achieve the best speed or shortest time as well as timed or free practice for such races or special stages;
- Government agencies, racing services and any other person or institutions involved in organising a meeting;

This waiver shall not include damage or harm to life, body or health – or any other damage – resulting from the intentional or grossly negligent breach of duty by the group of persons exempted from liability, their legal representatives or agents.

§ 4 I am aware that any violation of the provisions of §1 may result in the withdrawal of my press card or any other journalist credential.

§ 5 The areas the Stewards of the Meeting/Race Directors specifically assigned to me are marked on the race-track schematic, which I agree to consult and obey at every race.

§ 6 I am aware that the use of TV or video cameras requires the written authorisation of ADAC, the owner and administrator of the film and TV rights. The illicit use of TV or video cameras or devices may result in the withdrawal of my press card or any other journalist credential.
