## Reebok's "One Year of Sneakers" Giveaway

## **Official Rules**

## NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. Eligibility: Reebok's One Year of Sneakers Giveaway (the "Giveaway") is open to legal residents of the 50 United States and the District of Columbia, who are at least 18 years of age or the age of majority in their jurisdiction of legal residence as of the date and time of entry. Employees of Reebok International Ltd. and its parent, subsidiary and affiliate companies, and adidas America Inc. (the "Giveaway Entities"), as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. The Giveaway is subject to all applicable federal, state, provincial and local laws and regulations and is void where prohibited. - **3. Giveaway Description:** The Giveaway begins on January 1, 2019 at 12:01 p.m. Eastern Time ("ET"), and ends on December 31, 2019, at 11:59 p.m. ET (the "Giveaway Period"). Sponsor's computer is the official time-keeping device for this Giveaway.
- **4. How to Enter:** Participants may enter the Giveaway during the Giveaway Period by either (1) filling out completely and accurately an online entry form at www.Reebok.com/us/shoes\_for\_a\_year and signing up to receive promotional emails from Sponsor; or (2) sending a 3x5" card by first or second class mail, with your name, age, address, and email address, to the following address: Kate DeLanders, 2019 One Year of Sneakers Sweepstakes, 25 Drydock Ave, Boston, MA 02210. (All mail-in entries must be postmarked by the end of the Giveaway Period). By submitting the entry form, you will automatically receive one (1) entry in the Giveaway. **LIMIT: ONE (1) ENTRY PER PERSON, REGARDLESS OF METHOD OF ENTRY.** In the event more than one (1) entry is received from any one (1) person, the first entry processed will be considered the only valid entry received. In the event of a dispute regarding an entry, entries will be deemed made by the authorized account holder of the e-mail address submitted at the time of entry. The "authorized account holder" is the natural person who is assigned to the e-mail address by an internet access provider or other organization that is responsible for assigning e-mail addresses or the domain associated with the submitted e-mail address. Any potential winner may be required to show proof of being the authorized account holder.
- **5. Winner Requirements:** On or about on January 10, 2020, Sponsor will randomly select one (1) potential prize winner from among all eligible entries received during the Giveaway Period. Odds of winning a prize depend on the number of eligible entries received. Sponsor will notify the winners via the e-mail provided upon entry on or about January 10, 2020. The potential winner will be required to take the specified steps provided in the message with the requested contact information within five (5) days of receiving the notification that they are a potential winner. Liability (collectively, the "Release"). The Release must be returned within the time period indicated in the documents or the prize will be forfeited. Prize:** One (1) winner will receive one (1) year of sneakers to be awarded as follows: one (1) pair of Reebok sneakers to be mailed by Sponsor to winner for each month in 2020 (January 2020-December 2020). Each pair of sneakers to be awarded to winner will have a maximum value of \$250.00. Winner must provide Sponsor with his/her shoe size when providing winner verification materials for all winning sneakers. Winner must select an available in-line shoe size.

Total ARV of the prize: \$3,000.00.

Upon prize eligibility verification, Sponsor will present the winner with twelve (12) purchase codes. Each code will be valid for one (1) month during 2020 with a value up to \$250.00 to be used towards the purchase of one (1) pair of eligible Reebok sneakers in winner's shoe size via Reebok.com. Any amount due over \$250.00 will be winner's sole responsibility, including any shipping, handling, taxes or similar fees; Sponsor will have no obligation to provide additional compensation in the event winner's sneaker selection is less than \$250.00 during any month.
