

## Reebok® and Khalid Doggy Track Jacket Sweepstakes

### OFFICIAL RULES

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.** The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. The Sweepstakes begins on January 21, 2020 at 9:00 a.m. Eastern Standard Time ("EST"), and ends on February 3, 2020 at 11:59 p.m. EST (the "Sweepstakes Period"). Sponsor's computer is the official time-keeping device for this Sweepstakes.

- 1. Eligibility:** The Reebok and Khalid Doggy Track Jacket Sweepstakes (the "Sweepstakes") is open to legal residents of the fifty (50) United States and the District of Columbia, who are at least eighteen (18) years of age or the legal age of majority in their jurisdiction of residence as of the date and time of entry. Employees, officers, directors and agents of Sponsor (as defined below) and any of its parent, subsidiary and affiliate companies as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible to participate in the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein. Participation in the Sweepstakes constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to this Sweepstakes.

By submitting the entry form, you will automatically receive one (1) entry in the Sweepstakes. **LIMIT: ONE (1) ENTRY PER PERSON PER EMAIL ADDRESS.** In the event more than one (1) entry is received from any one (1) person, the first entry processed will be considered the only valid entry received and all additional entries will be void. All information must be filled out in order for the individual to receive an entry. Sponsor is not responsible for lost, late, illegible, incomplete, invalid, unintelligible, misdirected, technically corrupted or garbled entries, which will be disqualified, or for problems of any kind, whether mechanical, human or electronic. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. The prize will be awarded to the name corresponding to the email address submitted on the entry. In the event of a dispute as to the identity of an entrant, entry will be declared made by the authorized account holder submitted at the time of entry. "Authorized account holder" is defined as the natural person who is assigned to an email address by a wireless service provider, Internet access provider, Internet service provider or other organization (e.g. business, educational, institution, etc.) that is responsible for assigning email addresses associated with the submitted email address, as applicable. Potential winner may be requested to provide Sponsor with proof that he/she is the authorized account holder of the email address associated with the winning entry.
- 4. Winner Selection:** On or about February 4, 2020, Sponsor will randomly select ten (10) potential prize winners to win the prize from among all eligible entries received during the Sweepstakes Period. Odds of winning a prize depend on the number of eligible entries received during the Sweepstakes Period. Sponsor will notify the potential winners via the potential winner's email provided upon entry on or about February 5, 2020. The

potential winners will be required to take the specified steps provided in the notification message within forty-eight (48) hours of receiving the notification that they are a potential winner. To receive the prize, each potential winner may be required to sign an Affidavit of Eligibility with the Official Rules and a Release of Liability (collectively, the "Release"). Each potential winner is subject to verification, including verification of age. The Release must be returned within the time period indicated in the documents or the prize will be forfeited. 5. **Prize:** Ten (10) winners will each receive a Reebok doggy track jacket (top only). Approximate retail value ("ARV") per prize: \$75.00. Total ARV for all prizes awarded in this Sweepstakes: \$75.00.

**LIMIT ONE (1) PRIZE PER PERSON.** Prizes cannot be returned or exchanged. The prizes are awarded "as is" with no warranty or guarantee, either express or implied. Prizes cannot be transferred, substituted or redeemed for cash, except at Sponsor's sole discretion. Sponsor reserves the right to substitute any prize, or portion thereof, with a prize of comparable or greater value, in its sole discretion. The prizes cannot be used in conjunction with any other promotion or offer. Winner is responsible for his/her own costs and expenses associated with the acceptance or use of the prizes that are not specifically stated above. All federal, state and local taxes on the prize value are the sole responsibility of the winner. Sponsor will not replace any lost or stolen prize items. Winner may be required to produce government-issued identification. Except as specifically provided herein, winner is solely responsible for all expenses and fees, including, without limitation, taxes, related to any prize or this Sweepstakes. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of the Official Rules of this or any other promotion or in an unsportsmanlike or disruptive manner. rights to have damages multiplied or otherwise increased.
