



**Terms and Conditions:** Subject to all Terms and Conditions, the rebate offer (the “Promotion”) is available to all participants who have satisfied the eligibility criteria for the Promotion (“Participant”) as set out below. The Promotion begins on March 1, 2019 and ends on December 31, 2019 (“Promotional Period”). The Promotion is available to new customers of ADS Securities LLC (“ADSS”).

New customers who have not previously or do not currently hold an account with ADSS or its affiliates must open a live MetaTrader 4 or OREX account (the “Account”) and make a minimum initial deposit of US\$1,000 within the Promotional Period. Promotion is valid for residents of China, Taiwan, Macau, Malaysia, Thailand, Philippines, Indonesia, Australia and New Zealand only. Participant will receive a Bonus which is based upon the value of their initial deposit and the execution of the minimum notional volume as outlined in Table A below. The trading requirement for all initial deposits must be satisfied within ninety (90) days of funding the account. Minimum Bonus of US\$100 and maximum Bonus of US\$800 for new customers on their initial deposit; one (1) Bonus per qualifying deposit; maximum of one (1) Bonus per Account for new customers which make an initial deposit; one (1) account per Participant. The Promotion and Bonus are non-transferrable and cannot be combined with any other promotion or offer. Participant may withdraw funds during the Promotional Period, however, if any funds are withdrawn before the Participant has satisfied the trading requirements, the Participant will not be eligible to receive the Bonus. To participate in the Promotion, the Participant must enter **depbonus19** into the promo code field when submitting the application. The bonus will be paid within 10 business days after each month end if client has fulfilled the trading requirements.

Any Participants who hold an account with any registered broker, and open a new account with ADSS and make a minimum initial deposit of not less than US\$2,000 is eligible for an additional US\$50 bonus. After submitting the account opening application, Participants must provide documentation confirming a valid trading account with another broker and email to [cs.asia@adss.com](mailto:cs.asia@adss.com). The additional US\$50 bonus will be paid into the new ADSS account within 10 business days after each month end. Participants may withdraw funds during the Promotional Period, however, please note that the Participant will only be entitled to the US\$50 bonus if there are trading activities in the new account with ADSS. Otherwise, the US\$50 bonus will be deducted back from the account if the Participant wishes to withdraw funds without any trading activities.”

ADSS reserves the right, at its sole and absolute discretion to i) determine breaches and/or instances of abuse of the Promotion; ii) disqualify any individual that breaches the terms of, abuses or attempts to abuse, tampers or attempts to tamper with the Promotion iii) deny any bonus payment for any breach, potential breach, abuse, potential abuse, tampering and/or potential tampering of the Promotion or otherwise; iv) reject any account or account application for any reason; v) alter, amend, suspend or terminate the Promotion, or any aspect of it, at any time without prior notice; and vi) amend the terms of the Promotion, at any time without prior notice. ADSS will provide notification of such changes to the Promotion and/or the terms by way of the ADSS website. All participants will be automatically and immediately bound by such changes. Any dispute or situation not covered by the terms will be resolved by ADSS in a manner ADSS deems to be the fairest to all concerned; that decision shall be final and binding on all parties. If the terms are translated into a language other than English, then the English version of the terms shall prevail where there is an inconsistency. Example of Bonus payout:

1. New customer makes an initial deposit of USD\$2,500 and trades 5,000,000 in notional volume will be entitled to receive a \$100 Bonus.
