What is this product?**Type:**

A Spread Bet is a leveraged contract entered into with ADSS on a bilateral basis. It allows an investor to speculate on rising or falling prices in an underlying bond future.

An investor has the choice to buy (or go “long”) the Spread Bet to benefit from rising bond future prices; or to sell (or go “short”) the Spread Bet to benefit from falling bond future prices. The price of the Spread Bet is derived from the price of the underlying future. For instance, if an investor is long a bond Spread Bet and the price of the underlying bond future rises, the value of the Spread Bet will increase, and at the end of the contract ADSS will pay the difference between the closing value of the contract and the opening value of the contract. Conversely, if an investor is long and the cash price of the underlying bond future falls the value of the Spread Bet will decrease, and at the end of the contract the investor will pay ADSS the difference between the closing value of the contract and the opening value of the contract.

A Spread Bet referencing the underlying future price have a pre-defined expiry date, a date upon which the contract either automatically closes or is required to be manually rolled by the investor into the next period. The leverage embedded within all Spread Bets has the effect of magnifying both profits and losses. The leverage embedded within all Spread Bets has the effect of magnifying both profits and losses.

Objectives:

The objective of the Spread Bet is to allow an investor to gain leveraged exposure to the movement in the value of the underlying bond future (whether up or down), without actually needing to buy or sell the underlying future. The exposure is leveraged since the Spread Bet only requires a relatively small proportion of the notional value of the contract to be put down upfront as initial margin and is one of the key features of trading Spread Bets.

By way of example, if an investor buys a Spread Bet worth £1 per point and an initial margin amount of 20% and an underlying bond future price of 16000, the initial investment will be £3,200.00 (20% x 16000 x £1). The effect of leverage, in this case 5:1 (1 / 0.2%) has resulted in a notional value of the contract of £16,000 (3,200 x 5). This means that for each 1 point change in the price of the underlying market so the value of the Spread Bet changes by £1. For instance, if the investor is long and

the market increases in value, a £1 profit will be made for every 1 point increase in that market. However, if the market decreases in value, a £1 loss will be incurred for each point the market decreases in value. Conversely, if an investor holds a short position, a profit is made in line with any decreases in that market, and a loss for any increases in the market. The future Spread Bet has a pre-defined expiry date.

There is no recommended holding period and it is down to the discretion of each individual investor to determine the most appropriate holding period based on their own individual trading strategy and objectives. Failure to deposit additional funds in the case of negative price movement may result in the Spread Bet being closed out. This process may be automated and, accordingly, your positions may be closed-out with little or no notice being provided to you. ADSS also retains the ability to terminate any Spread Bet where it deems that the terms of the contract have been breached.

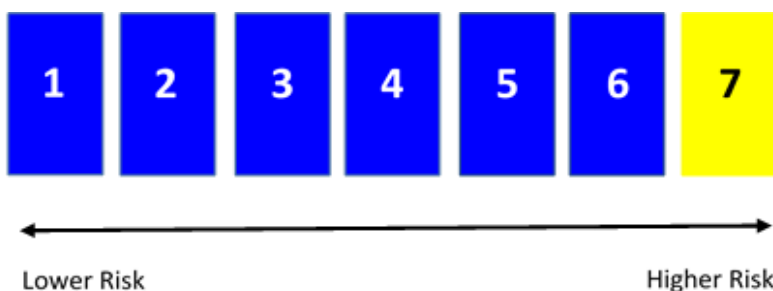
Investors will be given the option to roll their existing future Spread Bet contract into the next period e.g., from a March expiry into a June expiry. Rolling is manual at the discretion of the investor but failure to do so will result in the future Spread Bet being automatically closed at the expiry date. ADSS also retains the ability to unilaterally terminate any Spread Bet contract where it deems that the terms of the contract have been breached.

Intended retail investor:

Spread Bets are intended for investors who have knowledge of, or are experienced with, leveraged products. Likely investors will understand how the prices of Spread Bets are derived, the key concepts of margin and leverage including the risk/reward profile of the product. In addition, intended investors will also have appropriate financial means and the ability to bear losses of up to the total margin amount invested.

What are the risks and what could I get in return?

Summary Risk Indicator:



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 7 out of 7, which is the highest risk class. This rates the potential losses from future performance of the product at a very high level.

The risk indicator assumes that you may not be able to buy or sell your CFD at the price you wanted to due to volatility of the market or you may have to buy or sell your CFD at a price that significantly impacts how much you can get back.

Spread Bets are leveraged products that, due to underlying market movement, can generate losses rapidly and you may be required to deposit additional funds in order to maintain your positions. There is no capital protection against market risk, credit risk or liquidity risk. Retail clients are subject to negative balance protection which means, while it is possible to lose the entire amount invested, you are not able to lose more than your investment.

Beware of currency risk. You may receive payments in a different currency, so the final return you will get may depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Market conditions may mean that your Spread Bet on a bond future is closed at a less favourable price, which could significantly impact how much you get back. We may close your open Spread Bet contract if you do not maintain the minimum margin that is required, if you are in debt to the company, or if you contravene market regulations. This process may be automated and, accordingly, your positions may be closed-out with little or no notice being provided to you. This product does not include any protection from future market performance so you could lose some or all of your investment.

If we are not able to pay you what is owed, you could lose your entire investment. However, you may benefit from a consumer protection scheme (see “what happens if we are unable to pay you”). The indicator shown above does not consider this protection.

Performance Scenarios

The scenarios shown illustrate how your investment could perform, but are not an exact indicator. You can compare them with the scenarios of other products. The scenarios presented are an estimate of future performance based on evidence from the past on how the value of this investment varies. Please remember that past performance may not be a reliable indicator of future performance. What you get back will vary depending on how the market performs and how long you hold the Spread Bet. The stress scenario shows what you might get back in extreme market circumstances, and it does not take into account the situation where we are not able to pay you

What are the costs?

Trading a Spread Bet on an underlying bond future incurs certain of the following costs:

This table shows the different types of cost categories and their meaning

| One-off entry or exit costs | Spread | The difference between the buy price and the sell price is called the spread. This cost is realised each time you open and close a trade. |
| | Currency conversion | Any cash, realised profit and losses, adjustments, fees and charges that are denominated in a currency other than the base currency of your account, will be converted to the base currency of your account and a currency conversion fee will be charged to your account. |
| Other costs | Rollover cost | When contacting the dealing desk to roll over a CFD on an underlying futures contract you will be closed at the prevailing bid/offer of your existing contract and rolled in to the corresponding period bid/offer. |
| Incidental costs | Distributor fee | We may from time to time share a proportion of our spread, commissions and other account fees with other persons including a distributor that may have introduced you. |

How long should I hold it and can I take money out early?

Spread Bets are intended for short term trading, in some cases intraday and are generally not suitable for long term investments. There is no recommended holding period, no cancellation period and therefore no cancellation fees. You can open and close a bond Spread Bet at any time during market hours.
