Letter to School or Work Regarding Experimental Injections

NOTE, this letter is a template to be used in writing your personalized letter. Look for yellow highlighted text which indicates where you will need to delete the highlighted text and replace it with your information.

To: Whom It May Concern

Re: Covid-19 Experimental Injections & Related Requirements

You are hereby advised that any compulsory experimental Covid-19 injections ("Covid-19 injections") requirements by your institution are a violation of federal law. I urge you to advise all (STUDENTS OR EMPLOYEES) that they have the right to refuse or to take any COVID-19 injections. Any other action is contrary to federal law.

Covid-19 injections are ineffective.

The uncontroverted medical consensus is that existing Covid-19 injections are not effective, do not confer immunity, and are inferior to natural immunity. This is admitted openly today, including by the U.S. Health Agencies. The Centers for Disease Control and Prevention (CDC) Director, Dr. Walensky, stated on CNN, "What the vaccines can't do anymore is prevent transmission." Many other examples abound:

- 1. In a letter made public on September 12, 2022, Dr. Walensky acknowledged for the first time the CDC gave false information about its Covid-19 injection safety monitoring. She stated, "CDC performed proportional reporting ration (PRR) analysis between March 25, 2022, through July 31, 2022" and "CDC also recently addressed a previous statement made to the *Epoch Times* to clarify PRR were not run between February 26, 2021, to September 30, 2021."²
- 2. On August 11, 2022, the CDC surprised the nation when it announced that vaccinated persons and unvaccinated persons should now be treated the same, "regardless of vaccination status." ³ This recent action of the CDC motivated by new incoming data underscores the intrusiveness and pointlessness of any "vaccine mandate".

- 3. National Institute of Allergy and Infectious Diseases (NIAID) Director Dr. Anthony Fauci to NPR: "We know now as a fact that [people who received Covid-19 injections] are capable of transmitting the infection to someone else." 4
- 4. Dr. Anthony Fauci on November 12, 2021, referring to the experience of health officials regarding the injections: "They are seeing a waning of immunity not only against infection but against hospitalization and to some extent death, which is starting to now involve all age groups. It isn't just the elderly. It's waning to the point that you're seeing more and more people getting breakthrough infections, and more and more of those people who are getting breakthrough infections are winding up in the hospital." ⁵
- 5. World Health Organization (WHO) Chief Scientist Dr. Soumya Swaminathan: "At the moment I don't believe we have the evidence of any of the vaccines to be confident that it's going to prevent people from actually getting the infection and therefore being able to pass it on." ⁶
- 6. Chief Medical Officer of Moderna Dr. Tal Zaks: "There's no hard evidence that it stops [the Covid-19 injected] from carrying the virus transiently and potentially infecting others who haven't been vaccinated." ⁷
- 7. The Surgeon General of the State of Florida, Dr. Joseph Ladapo, MD, Ph.D.: "...the infections can still happen whether people are vaccinated or not. That's very obvious." ⁸
- 8. Professor Sir Andrew Pollard who led the Oxford Covid-19 injection team: "We don't have anything that will stop transmission, so I think we are in a situation where herd immunity is not a possibility and I suspect the virus will throw up a new variant that is *even better* at infecting vaccinated individuals." ⁹

- 9. Dr. Jay Bhattacharya, MD, Ph.D., Professor of Health Policy, Stanford University: "Based on my analysis of the existing medical and scientific literature, any exemption policy that does not recognize natural immunity is irrational, arbitrary, and counterproductive to community health." ¹⁰
- 10.2008 Nobel Prize Winner in Medicine Dr. Luc Montagnier (also winner of the French National Order of Merit and 20 other major international awards): "The vaccines don't stop the virus, they do the opposite they 'feed the virus,' and facilitate its development into stronger and more transmissible variants..." ¹¹
- 11.A study of Covid-19 outbreaks in July 2021 published in *Eurosurveillance* observed that 100 percent of severe, critical, and fatal cases of Covid-19 occurred in injected individuals. The authors stated that the study "challenges the assumption that high universal vaccination rate will lead to herd immunity and prevent Covid-19 outbreaks." ¹²
- 12.Dr. Martin Kulldorff, Professor of Medicine at Harvard Medical School: "The bottom line is that these vaccines do not prevent transmission." ¹³
- 13.Dr. Sunetra Gupta, Infectious Disease Epidemiologist and Professor of Theoretical Epidemiology at the University of Oxford: "[I]t is really not logical to use [these] vaccines to protect other people ... I don't think they should be forced[] on the understanding simply because this vaccine does not prevent transmission." ¹⁴
- 14.Moderna Chief Medical Officer Tal Zaks admitted Covid-19 injections do not create immunity who warned that: "[T]he trial results show that the vaccine can prevent someone from getting sick or 'severely sick,' from Covid-19, however, the results don't show that the vaccine prevents transmission of the virus." ¹⁵

Covid-19 injections are experimental.

Covid-19 injections have not been approved or licensed by the U.S. Food and Drug Administration ("FDA"). Covid-19 injections are instead treatments and must be analyzed as such under the law. Moreover, Covid-19 injections are approved under an Emergency Use Authorization ("EUA") and for *investigational* use only. ¹⁶ Covid-19 injections lack requisite studies and are not approved medical treatment. The FDA's guidance on EUA of medical products requires the FDA to "ensure that recipients are informed to the extent practicable given the applicable circumstances ... That they have the option to accept or refuse the EUA product ..." ¹⁷

Federal statutory law expressly mandates that experimental drugs being used subject to an EUA, such as these Covid-19 injections, are *strictly voluntary*. Title 21, Section 360bbb-3 of the Federal Food, Drug, and Cosmetic Act (the "FD&C Act") vests the Secretary of Health and Human Services with the permissive authority to grant Emergency Use Authorization ("EUAs") providing that appropriate conditions designed to ensure that individuals to whom the product is administered are informed:

- 1. that the Secretary has authorized the emergency use of the product;
- 2. of the significant known and potential benefits and risks of such use, and of the extent to which such benefits and risks are unknown; and
- 3. **of the option to accept or refuse administration of the product**, of the consequences, if any, of refusing administration of the product, and of the alternatives to the product that are available and of their benefits and risks. ¹⁸

The right to avoid the imposition of human experimentation is fundamental, and is rooted in the Nuremberg Code of 1947, has been ratified by the 1964 Declaration of Helsinki, and further codified in the United States Code of Federal Regulations. In addition to the United States regarding itself as bound by these provisions, these principles were adopted by the FDA in its regulations requiring the informed consent of human subjects for medical research. It is unlawful to conduct medical research, even in the case of an emergency, unless steps are taken to secure **informed consent** of all participants. ¹⁹

Courts have consistently upheld the patient's right to refuse unwanted medical treatments on constitutional grounds for decades. See *Mills v. Rogers*, 457 U.S. 291, 102 S.Ct. 2442, 73 L.Ed.2d 16 (1982), *Guardianship of Roe*, 383 Mass. 415, 421 N.E.2nd 40 (1981), *Cruzan v. Director, Missouri Department of Health*, 497

U.S. 261, 280 (1990), *Washington v. Harper*, 494 U.S. 210, 110 S.Ct. 1028, 108 L.Ed.2d 178 (1990), *Riggins v. Nevada*, 504 U.S. 127,112 S.Ct.1810, 118 L.Ed.2d 479 (1992), and *Sells v. United States*, 539 U.S. 166 (2003). Preservation of the absolute right of voluntary, informed patient consent and medical freedom is a paramount consideration here. Informed and voluntary consent to medical treatments can never be coerced.

Four Covid-19 injections have been issued an EUA:

- **1. 7/13/22 Novavax** FDA issued an EUA for recipients 18 years of age or older; 12-17 years of age on 8/22/22.
- **2. 2/27/21 Johnson & Johnson** ("Janssen") FDA issued an EUA for recipients 18 years of age or older.
- **3. 12/18/20 Pfizer/BioNTech** FDA issued an EUA for recipients 18 years of age or older; 12-17 years of age on 5/10/21; 5-11 years of age on 5/20/22; 6 months—4 years of age on 5/20/22; 6/17/22; and on 8/9/22 the FDA issued an EUA for the *Bivalent Booster* for recipients 18 years and older.
- **4. 12/11/20 Moderna** FDA issued an EUA for recipients 16 years of age or older; 12-17 years of age on 5/10/21; 5-11 years of age on 5/20/22; 6 moths—4 years of age on 5/20/22; 6/17/22; and on 8/9/22 the FDA issued an EUA for the *Bivalent Booster* for recipients 18 years and older.

Each of the above EUAs were issued in conjunction with a similarly worded "Fact Sheet for Recipients and Caregivers Sheet" ("Fact Sheet") from the FDA. For example, the Janssen Fact Sheet contains the following notice:

"INFORMATION TO PROVIDE TO VACCINE

RECIPIENTS/CAREGIVERS" As the vaccination provider, you must communicate to the recipient or their caregiver, information consistent with the Fact Sheet (and provide a copy or direct the individual to the website to obtain the Fact Sheet) prior to the individual receiving the Janssen Covid-19 Vaccine, including:

- FDA has authorized the emergency use of the Janssen Covid-
- 19 Vaccine, which is not an FDA approved vaccine.
- The recipient or their caregiver has the option to accept or refuse the Janssen COVID-19 Vaccine.

The significant known and potential risks and benefits of the Janssen Covid-19 Vaccine, and the extent to which such risks and benefits are unknown. ²⁰

Clearly, any attempt to force anyone to take a Covid-19 injection is a violation of federal law and the conditions under which the Covid-19 injections have been authorized for use. The law is clear, experimental medical treatment cannot be mandated.

Businesses are not shielded from liability with experimental agents.

Under the 2005 PREP Act enacted by Congress, pharmaceutical companies that manufacture EUA vaccines are shielded from liability related to injuries and damages caused by their experimental agents. However, any employer, public school, or any other *entity or person* who mandates Covid-19 injections on any human being is not protected from liability for any resulting harm. While vaccine manufacturers may be shielded from liability, your institution is not protected, and neither are you. ²¹

You are hereby on notice that if you illegally or irresponsibly mandate EUA medical therapies on (STUDENTS OR EMPLOYEES), such as the experimental Covid-19 vaccine candidates, I may have no choice but to take legal action, and you may be personally liable for the resulting harm.

I urge this institution to comply with the FD&C Act and the terms of the EUA and its accompanying Fact Sheet, and to advise all (STUDENTS OR EMPLOYEES) of their right to accept or refuse any Covid-19 injection. Any other course of action is contrary to federal law.

Thank you for your time and for protecting the best interest of your (STUDENTS) OR EMPLOYEES).
