

MEMORANDUM



We, representatives of the indigenous peoples and colonized regions of the Russian Federation, by this Memorandum on the Termination of the Russian Federation Existence, on the anniversary of the agreements that de jure ceased the USSR existence - the main totalitarian state and a human-hating regime of the 20th century, declare the following:

1. The Russian Federation is a terrorist state: it represses its citizens, colonially exploits the regions, uses the practice of forcible assimilation, destruction, and outright genocide towards indigenous peoples inside the country and neighboring peoples/ states, unleashes wars to seize the territories of neighboring states, which not only violates all norms of international law and ethics but dooms tens of millions of its citizens to death, poverty and isolation.

Many years ago the Russian Federation has irretrievably lost any internal and external legitimacy: independent courts do not function, there are no opportunities for a change of power through fair elections, and all institutions work only in the interests of a corrupt imperial regime led by war criminals.

The Russian Federation is a bankrupt state, therefore, by our decision to independence and secession from its structure, we terminate the existence of the Russian Federation as a subject of international law.

- The secession of all newly independent states will take place only by peaceful means.
 Any territorial, political, and/or economic disputes will be resolved only at the
 negotiating table, by finding compromises through the mediation of the free world
 countries.
- 3. Simultaneously with the declaration/return of their independence and the establishment of de facto sovereignty on their lands, all independent states of the post-Russian space undertake obligations on the complete renunciation of nuclear and all other types of weapons of mass destruction, with their transfer for disposal to NATO member states and /or the IAEA.
- 4. All the Russian Federation assets, as well as its debts, including the reparations payment to the states that suffered from its insane military aggression, we undertake to divide proportionally among ourselves. For this purpose, a special International Conference will be convened with the participation of the EU and NATO countries, as well as the state's victims of terrorism and wars unleashed by the Russian Federation over the past 30 years (Moldova, Ichkeria, Sakartvelo, Ukraine).
- 5. All independent states of the post-Russian space undertake to hold an open tribunal against terrorists and war criminals, to implement comprehensive programs of denazification and de-communization, and also to conduct a lustration for the entire former imperial apparatus of the Russian Federation. Each of the states gives guarantees that it will not harbor criminals and terrorists on its territory, who will be under investigation.

We understand the practical implementation of the above, de facto, may take not even a few months, but several years, that is why no matter when all the above plans come true, we will do everything possible and impossible every day to speed up this process, bringing the Day of Peace, Freedom, and Independence closer to all people in Eastern Europe and Northern Eurasia, to finally dismantle this Terrorist and Colonial Empire - the Russian Federation.
