 - 1. Basis of Design: Subject to compliance with project requirements, the design is based on the following: USG Interiors, LLC, "[Radar Basic] [Radar Basic Illusion]".
 - 2. Classification: Provide ceiling panels complying with ASTM E 1264 for type, form and pattern as follows:
 - a. Type: III, mineral base with painted finish
 - b. Form: 2, water felted
 - c. Pattern: [C & E, perforated, small holes and light texture] [C, E & K, perforated, small holes, light texture and surface scored].
 - 3. Color: Flat White 050.
 - 4. LR: Not less than 0.83.
 - 5. NRC: Not less than [0.50] [0.55] [0.60].
 - 6. CAC: Not less than [33] [35] [40].
 - 7. Edge/Joint Detail: [SLT Beveled Reveal] [FLB Flush Beveled Reveal] [SF Tongue and Grooved with beveled edge] [SQ Square].
