


## Roll-In Shower Stall

The shower enclosure shall be Aquarius model G 6233 BF-F center, right or left. Finished surface shall be of an applied acrylic. The base shall be attached to the sump of the unit in such a manner to form an integral part with an inner and outer coating of polyester resin. The unit shall have outside dimensions of  $62^{\circ}$  x 32  $3/4^{\circ}$  x 78  $1/2^{\circ}$ . The unit meets ADA, ANSI Z124.1.2, CSA B45.5, and MAS.

This enclosure shall be equipped with the following installed accessories:


1) One 36" x 1 1/4" diameter stainless steel peened horizontal grab bar on the back wall, 2) One 22" x 1 1/4" diameter stainless steel peened horizontal grab bar on the side wall, both with 1 1/2" statute clearance, mounted with stainless steel bolts, and secured from the rear with 3" x 3" x 11 gauge metal mounting plates, 3) 26" x 21" frameless white padded fold up seat. 4) One inch diameter, 18 gauge stainless steel curtain rod with receiver cups, 5) Factory installed Armor Core Easy Base, 6) 3/4" change of level threshold.


Available Options: 7) Valve package includes: Hand held shower set, swivel connector, 60" flex hose, vacuum breaker, 30" slide bar, wall water outlet fitting, 8) Green anti-bacterial shower curtain and hooks, 9) White shower curtain and hooks. 10) Nurses call box drilling.

This unit features the outside dimensions of 62" of overall width. This does not allow for full enclosure of the bolts that are used to secure the bars and seat in place. This may require the need to notch study to allow for bolt clearance for installation.

For a dry wall enclosed fire wall installation, adjustment of the wallboard may be necesary to provide clearance of the bolts while maintaining the integrity of the drywall fire wall enclosure.




