



MEC Avalanche Safety Grant

Background:

Avalanche Canada seeks to inspire, engage, and empower recreationists to enjoy Canada's winter backcountry safely by developing, coordinating, promoting, and delivering world-class public avalanche safety programs and services in Canada. Avalanche Canada recognizes that racialized communities, namely, Black, Indigenous, people of colour (BIPOC) and organizations serving these communities, face disproportionate barriers in accessing winter backcountry pursuits in Canada. Avalanche Canada and MEC are partnering to reduce some of these barriers by offering Avalanche Skills Training (AST) grants for BIPOC serving organizations to enable them to pursue their outdoor adventures safely.

The MEC Avalanche Safety Grant is intended to help increase accessibility to winter backcountry adventures for non-profit organizations serving racialized communities. The MEC Avalanche Safety grant offers operating funds for BIPOC led and serving organizations to cover the costs of Avalanche Skills Training (AST 1) courses.

The financial support funds operational costs for up to 4 AST 1 courses in BC and Alberta with a total of \$2500 funding per course (covers 8 participants/course) to take place between December 15, 2022 – April 3, 2023. Further details of grant below:

What Avalanche Canada will fund/provide access to:

- Funds for AST instructor wages and travel costs
- Assistance with vetting AST providers if required
- Printed resources for 8 participants
- Avalanche safety equipment (transceiver, shovel, probe) for use on the course
- Classroom venue and AV costs if not covered under instructor fees

What your organization will be responsible for:

- Administration of the course, including:
 - Scheduling course dates,
 - Hiring and communication with a licensed AST Provider*
 - Vetting of the appropriate students for this course (8 skiers OR 8 snowshoers, cannot be mixed)
 - Assigning point person for all communication in regards to the course (instructor to students and Avalanche Canada to your organization)
 - Being responsible for the "Tool Box" (which includes the necessary avalanche safety equipment for 8 students) for the duration of the course (including receiving the shipment until it has been shipped to the next locale)
 - Submitting a final report to Avalanche Canada post course

- Securing a classroom space necessary for one day. Liaise with AST instructor to ensure there is a meeting space that will accommodate 9 people (8 participants/1 instructor), with a screen (or white wall) and an LCD projector.
- Maintaining timeline: The AST 1 course will be delivered between the dates of December 15, 2022 – April 3, 2023.
- Utilizing discretion regarding participant gear: students require skis/skins/poles (or snowshoes if
 a snowshoe course), clothing, backpack, and personal items needed for the field day. It is up to
 the discretion of the organization to determine if some of the grant funds will be used to assist
 some equipment rentals for students.
- Ensuring funds received are used for the following:
 - Instructor wages
 - Classroom rental (if not included in instructor fees)
 - o Equipment rental (skis, skins, boots, snowshoes) for students

*Note: Avalanche Canada can assist with vetting AST providers

About the Avalanche Skills Training (AST) 1 course:

If you venture out of bounds, off the trails, or into the backcountry an AST 1 is your place to start. You don't need any experience to take this course. It is a must for everyone recreating in the backcountry.

This is the course where you'll learn how to recognize avalanche terrain and how to companion rescue. An AST 1 is a minimum of two days with both classroom and field components. You need to take this course first and so should your friends because just one person trained in a group is not enough. Everyone in your group should take an AST 1. Finally, recognize an AST 1 course is only the beginning—the avalanche pros will tell you avalanche training is a lifelong process.

What you will learn:

- Avalanche formation and release.
- How to identify avalanche terrain.
- The basics of trip planning.
- Optimal use of tools and resources like the avalanche forecasts to mitigate your avalanche risk.
- Using appropriate travel techniques in avalanche terrain.
- Intro to companion rescue.

Organization Eligibility:

We fund AST Grants for organizations with the following criteria:

- BIPOC led (defined as where at least two thirds of senior leadership are held by those who selfidentify as Black, Indigenous, or People of Colour) or serving organizations supporting diversity in the outdoors
- Must be based in and serving BIPOC/racialized communities in BC and AB

- Non-profit, charities and community groups are eligible. (Registered, or planning to register as a non-profit preferred but not a mandatory requirement.)
- Organizations that support programs to remove barriers for BIPOC/racialized communities to fulfill outdoor pursuits.

We do not fund AST grants for:

- Sports teams
- Political organizations
- Commercial or incorporated enterprises
- Professional organizations or trade groups

Applications open from September 26, 2022 to November 6, 2022 Final decisions will be made by November 14, 2022 AST courses to be run between December 15, 2022 and April 3, 2023 Final report due April 30, 2023
