




IMPORTANT NOTE: When sliding the unit into the face, the feet will need to be removed.




Three (3) Rear Brackets are provided to prevent the unit from sliding back. (The brackets can be mounted four ways. **(FIGURE A)**




1) Insert Rackshelf Ears into the Rackshelf Face, behind the tabs.



2) Place the bottom on top of the ear, aligning oval holes.
