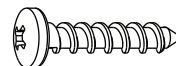

REQUIRED TOOLS

- #2 Phillips Screwdriver (at least 6" long)
- 1/4" Drill Bit
- Drill
- Hammer

INSTALLATION

NOTE: Installation of the brackets must be done with the C5 top off.

1. Remove the side panel on the side you wish to install the shelf.
2. Prepare your side panel based on the following C5 models:

- For Thermolaminate and HPL C5 models, enlarge pre-drilled mounting holes from the inside of the side panel using a 1/4" drill bit **(FIGURE A)**.
- All other models already have pre-drilled mounting holes.

NOTE: On Klasik C5 models, one less T-nut and screw is used because there is no hole in the location closest to the front hinge plate.

3. Hammer T-nuts into each of the holes from the inside of the side panel. **(FIGURE A)**

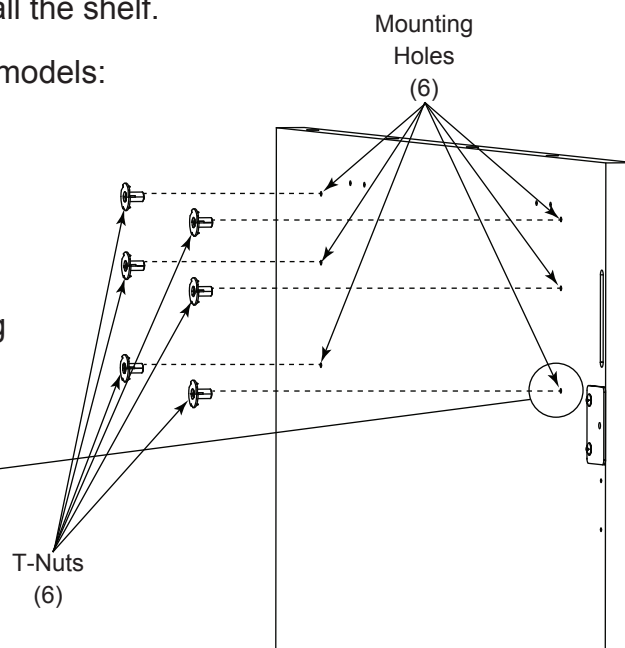

4. Install shelf brackets using the following screws based on your C5 model:

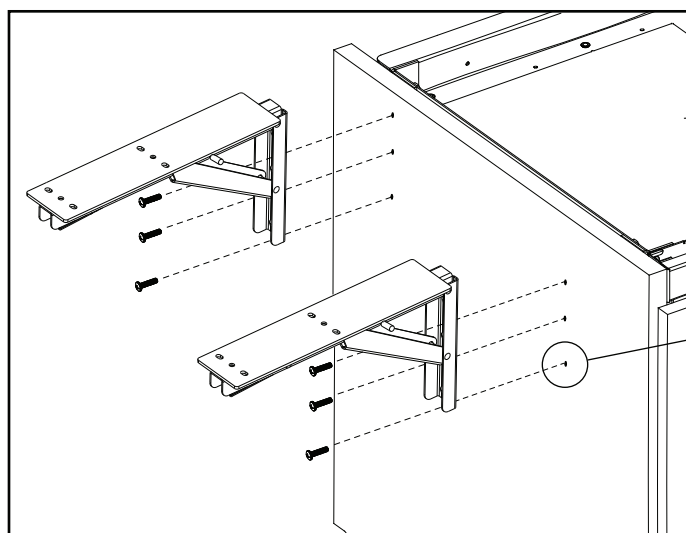

- On Sota and Klasik C5 models, use 10-32 x 3/4" screws. **(FIGURE B)**
- On Moderno C5 models, use 10-32 x 1 3/4" screws.

Use 3 screws per bracket and leave them loose for any necessary adjustments.

NOTE: On Klasik C5 models, one less T-nut and screw is used because there is no hole in the location closest to the front hinge plate.

INSTALLATION (CONTINUED)

5. Remove the plastic tube from both brackets. **(FIGURE C)**

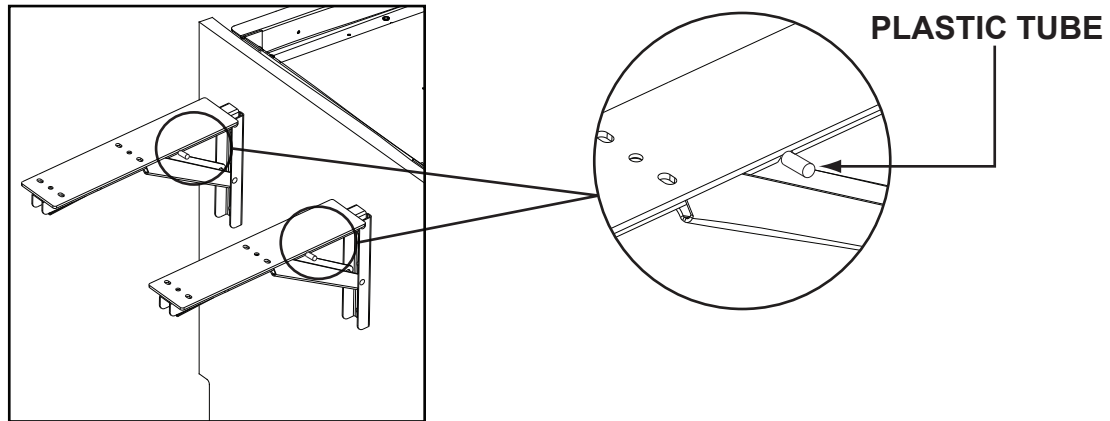

NOTE: Ensure the brackets are in the full open position prior to installing the shelf.

6. Place the shelf on the brackets. Install shelf using using (8) 10 x 3/4" Phillips pan head wood screws, 4 places per bracket. Leave the screws loose for any necessary adjustments. **(FIGURE D)**
7. Install the C5 top. Ensure the top is properly aligned with the shelf prior to screwing it down to the frame.
8. Once the shelf and the top are aligned properly, tighten the previously installed screws. **DO NOT OVERTIGHTEN.**

NOTE: Additional holes are provided to install the shelf on either side of the credenza.

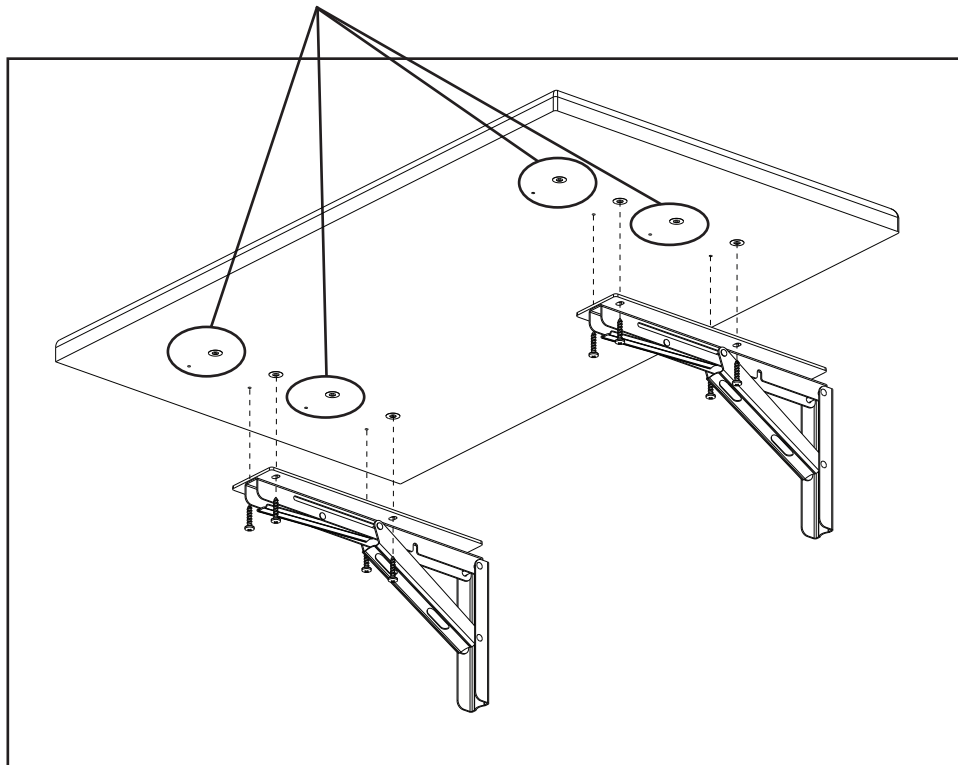
