



# INSTALLATION INSTRUCTIONS

## C5 ADJUSTABLE REAR RAIL BRACKET

### C5 SERIES

#### INSTALLATION

1) Remove lacer bars, and then remove the rear rackrail.




2) Install the four adjustable rear rail brackets (two per side) using the 16 provided oval nuts and screws.

NOTE: Second pair of rear rail brackets removed for clarity.

## INSTALLATION CONTINUED

- 3) Install the rear rackrail using the four provided oval nuts and screws.

(4 places,  
2 per panel)



Phillips head  
screws  
(4 places,  
2 per rail)

- 4) Install second pair of rear rail brackets, rackrail and lacer bars.

NOTE: The rackrail can be installed into the fixed holes or slots (or a combination of both) on the rear rail bracket
