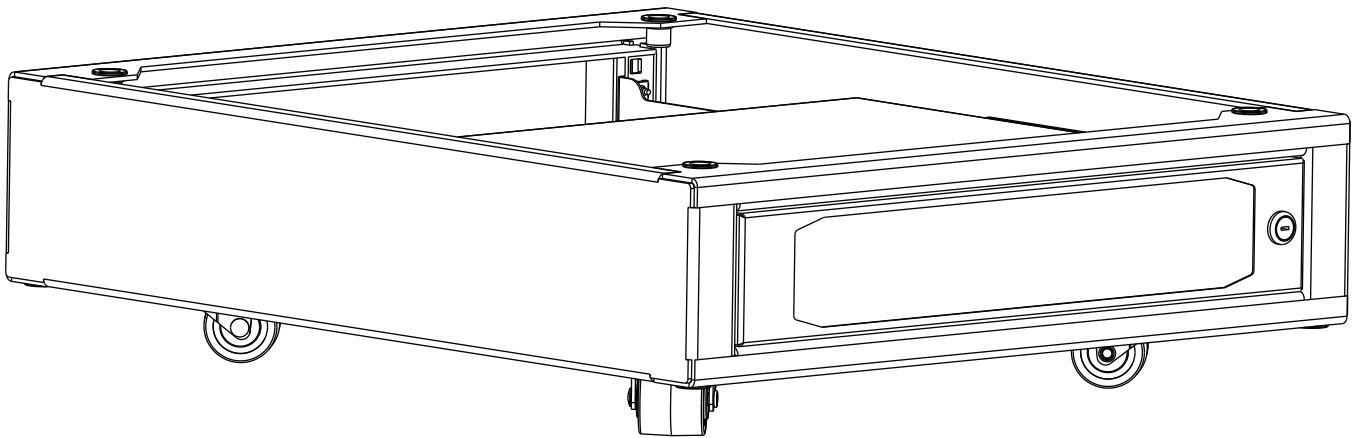

CAUTION: To avoid an unstable condition, place heavier components at the bottom of the enclosure. When more than one component is placed in the enclosure, begin at the bottom of the enclosure and place equipment at the lowest available point, evenly distribute weight (horizontally) within the enclosure.

Component weight should be distributed as follows:

- 1/2 of the total component weight (at a minimum) placed in the bottom third of the cabinet.
- 1/4 of the total component weight (at a maximum) placed in the middle third of the cabinet.
- 1/4 of the total component weight (at a maximum) placed in the top third of the cabinet.



CAUTION: All installation and assembly steps must be performed by qualified personnel.



CAUTION: Ensure that the floor has a structural load capacity that will support the weight of the cabinet fully loaded with equipment.



CAUTION: The following parts are not effectively bonded to the protective earth terminal: Rack rails, lace bars, Lever Lock™, shelves, baffle, blanking panels, fans, and cable management. If any part needs to be bonded to the protective earth terminal it shall be done in accordance with Article 250 of the National Electrical Code.



CAUTION: To reduce the risk of personal injury and conform to the UL listing, the system must be grounded and bonded in accordance with Article 250 of the National Electrical Code.



CAUTION: Power cord, for fans or other accessories, need to be secured to ensure that they are routed away from pinch points and moving parts.



CAUTION: To reduce the risk of personal injury, these mounting instructions must be followed and proper weight capacities must be observed.



CAUTION: Use caution when moving the cabinets with casters installed. There is a possibility of tilting. Always move cabinet over smooth floor surfaces and a short distance only. The enclosure should only be moved by pushing on the front or rear of the cabinet. Do not push from the side.



CAUTION: Casters (if used) are not intended to support excessive cabinet loads for extended periods of time. Please refer to "Weight Rating" for recommended weight capacity. Always use levelers (LF-HD, not provided) to stabilize the cabinet after locating.



CAUTION: Do not attempt to unload or move the enclosures alone. Make sure to have sufficient amount of personnel and equipment to safely move this product.



CAUTION: Watch hands and fingers around pinch points.



CAUTION: Individual components mounted inside of the wall mount rack must have their own fire enclosure.

- 1/2 du poids total de la composante (au minimum) placé dans le tiers inférieur de l'armoire.
- 1/4 du poids total de la composante (au maximum) placé dans le tiers médian de l'armoire.
- 1/4 du poids total de la composante (au maximum) placé dans le tiers supérieur de l'armoire.

ATTENTION: Veiller à ce que le sol a une capacité de charge structurelle qui supporter le poids de le cabinet entièrement chargé avec l'équipement.

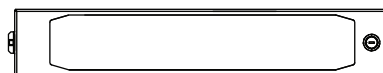

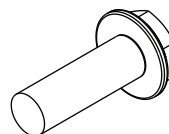
Front Panel

INTRODUCTION

This instruction sheet shows you how to attach your rack onto your UPX base option.

NOTE:

- For information specific to UPX operation, refer to the Line Interactive Uninterruptible Power Supply (UPS) user manual (100-00072) at www.legrandav.com or contact support at 1-800-266-7225.
- The panels are not preinstalled on the UPX base (as shown in these instructions) when the option is purchased as part of a preconfigured Forward enclosure, but are preinstalled when the option is purchased by itself.

INSTALLING OR REMOVING THE PANELS

1. If not part of a preconfigured Forward enclosure, remove your UPX Base (A) option from all packaging and leave it on the ground.

NOTE: If purchased as part of a preconfigured Forward enclosure, unpack your product using the unpacking instructions (100-00018) at www.legrandav.com.

2. Use your keys (B and C) to operate the locks on front (D) and rear (E) panels in order to distinguish them, as shown.

NOTE: Distinguish front (D) and rear (E) panels by matching corresponding front (D) and rear (E) key ID #s. (**FIGURE A**)

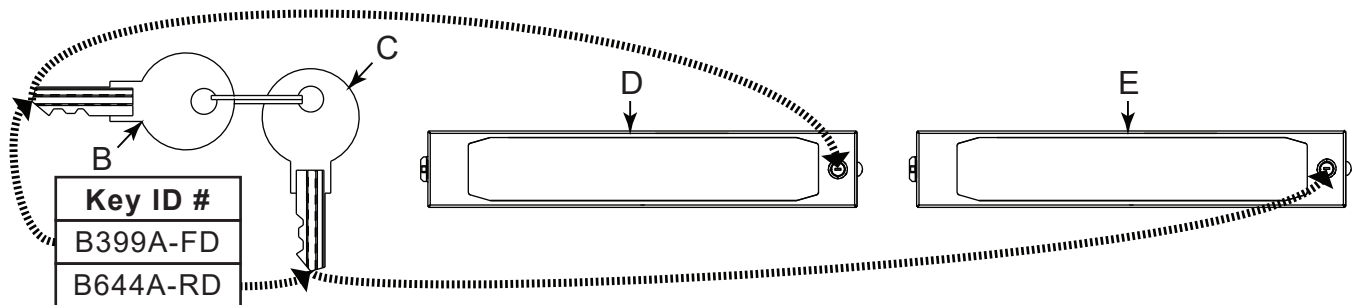
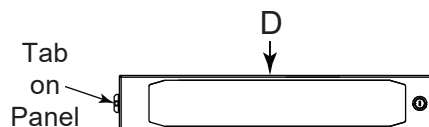

3. Use the front panel key (B) to open the lock on the front panel (D).
4. With the key still in the lock and the lock still open, insert the tab on the front panel (D) into the slot on the left side (facing) of the front panel opening on the UPX Base (A) as shown. (**FIGURE B**)

NOTE:

- Key not shown in lock on panel for clarity.
- The panel may be reversed, with the tab going in the slot on the right side (facing) of the front panel opening, if desired.



Slot on left side of UPX Base

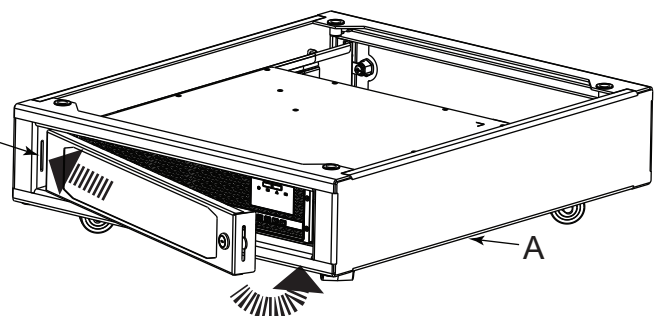
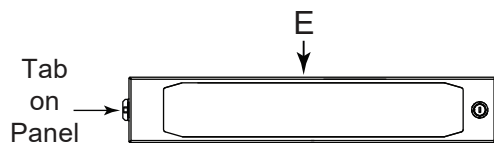

5. Use the front panel key (B) to lock the panel (D).

INSTALLING OR REMOVING THE PANELS (CONTINUED)

6. Repeat steps 2 - 5 using the rear panel key (C) to attach the rear panel (E) to the opposite side of your UPX Base (A) as shown. **(FIGURE C)**



NOTE: Key not shown in lock on panel for clarity.

Slot on left side of UPX Base

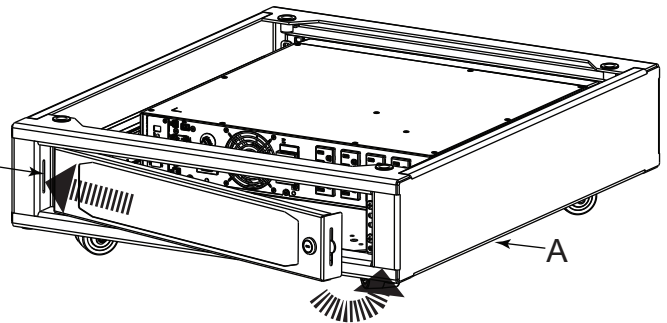

7. Reverse steps 3 - 6 to remove panels.

ATTACHING THE RACK TO YOUR UPX BASE OPTION

1. Position your UPX Base (A) on the ground and as close as possible to your desired final location.

NOTE:

- Make sure the front of the UPX Base (and the UPX unit inside) is facing your desired direction.
- Optional Leveling Feet (LF-HD) are available for purchase.
- Holes are provided on the bottom of the UPX Base for bolting to the floor, if desired. For more information, refer to the technical specification (120-00003) at www.legrandav.com.

2. If you purchased the optional leveling feet, install them now and completely tighten them to the bottom of the base.

3. Carefully team lift your rack and place it onto the top of the UPX Base (A) as shown. **(FIGURE D)**

4. Use a $\frac{3}{4}$ " wrench and (4x) UPX Base bolts (F, one in each corner) to attach the rack to the base by putting the bolts through the holes in the bottom corners of the rack and into the threaded holes on the top of the UPX Base (A).

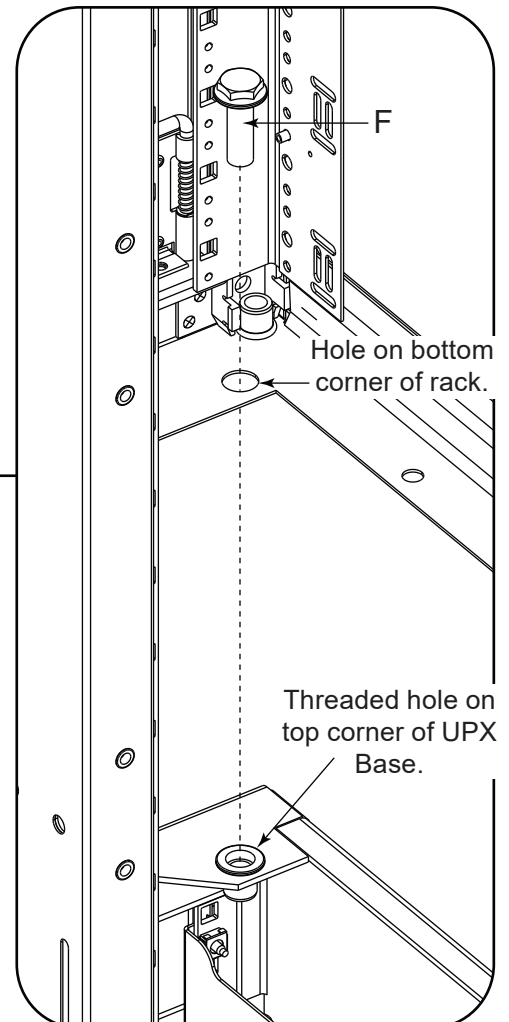
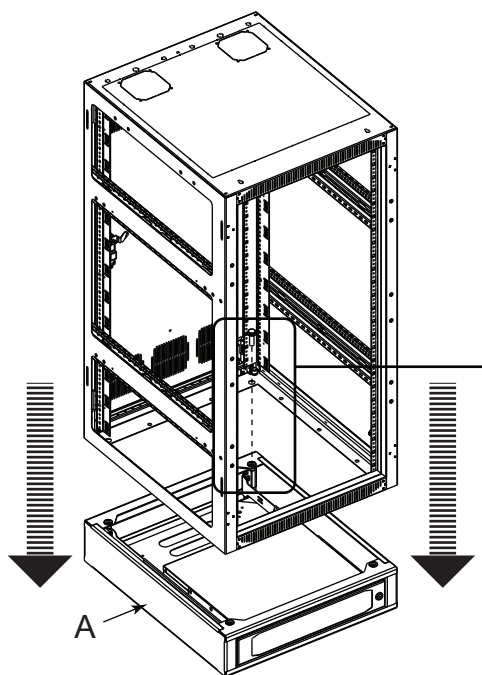

5. If you purchased and installed the optional leveling feet, loosen them now until they properly stabilize your rack in its final location.

BONDING THE UPX BASE OPTION

1. Attach bonding wire (not provided) to a bonding stud located on either side of the UPX Base (A).
(FIGURE E)
2. Properly attach the other end of the bonding wire (not provided) to main protective earth terminal (PET) on the rack.



CAUTION: A bonding wire (not provided) must be used when attaching the UPX base to ensure proper bonding.

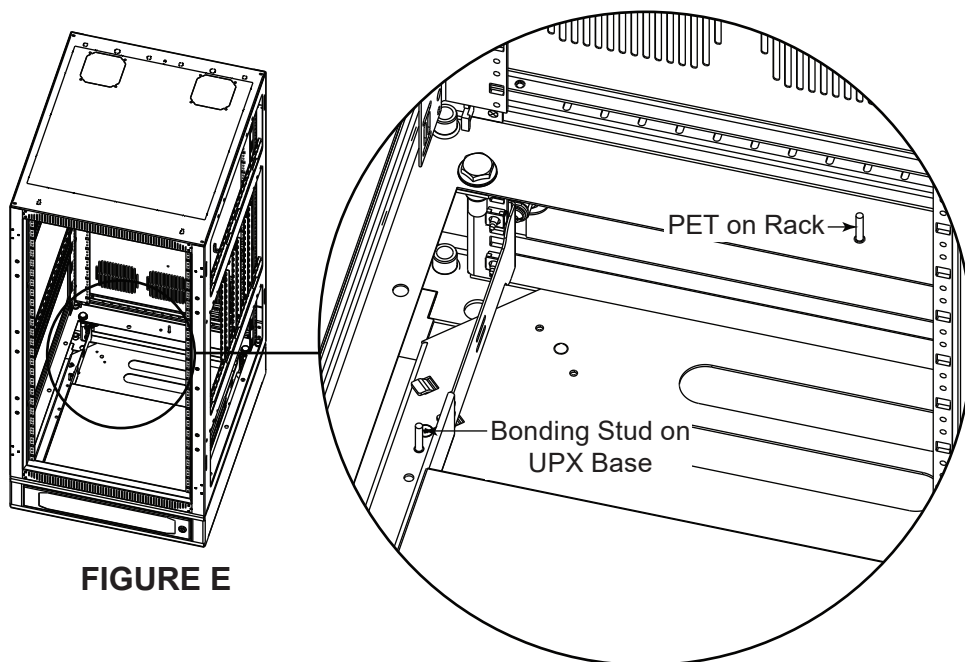
