### ENVIRONMENTAL IMPACTS

The evaluation of environmental impacts examines the stages of the Reference Product life cycle: manufacturing, distribution, installation, use, and end of life. It is representative of products marketed and used in North America.

The following modelling elements were taken into account:

Manufacturing	All transport for the manufacturing of the Reference Product, including materials and components, has been taken into account. Production of raw materials and packing, as well as the product manufacturing is accounted for. The waste generated during manufacturing phase has been included. Manufacturing process have been accounted for using electricity, fuel and water use for the manufacturing portion of the facility.
Distribution	Transport between the last distribution center and an average delivery to the sales area.
Installation	The end-of-life of the packaging is taken into account at this phase.


