Mr. Sharkey and Councilman Conway:

I was going to wait until early next week, when Mr. Sharkey returns to the office, to write, but our situation, and the lack of response, continues to frustrate our group--all citizens of Baltimore. This morning, just before 8am, I tried to cross Bellona to walk my dog to the vet, on York Rd. I had to contend with this truck--which is not supposed to be on this road! See the picture below. There's also a video of it, linked. Major Shorter has been good enough to say that we can track truck traffic and notify him of patterns. Our group has done some tracking--but really this seems

inefficient, at best. We know the trucks. We know the vendors they go to. Shouldn't there be a quicker way to resolve this on-going problem? Indeed there is: It's fully outlined in our previous correspondence.

The lack of responsiveness to our concerns escalates our frustrations--as I'm sure you've seen in some of the correspondence. Our group has now joined with a group of parents and teachers from The Tunbridge School, located at [5504 York Rd](#). You've likely received their correspondence (attached) previously. They are 50 in number at this point--and still growing.

Their issues are related to the issues articulated by Make Bellona Ave. Safer NOW! (MBASN!): Speeding traffic endangering pedestrians and poor infrastructure to address the problem. The Tunbridge PTO is talking about parents and kids trying to cross the street (intersection of York/Harwood) to get to and from school. As a public safety issue, it doesn't get more simple than this.

And, of course, this intersection connects to the concerns MBASN! has communicated because the issues of the entire corridor are intertwined: You can't just fix a single problem without fully contemplating and addressing the whole problem.

Here's what we want:

1. Immediate responses and plans from DOT related to our requests. You've said you have plans, we want to see them.
2. From Councilman Conway: A meeting, at your earliest convenience, in person, to hear and address our collective concerns. Tunbridge can host the meeting. Of course DOT should attend--but, alas, in the past when DOT has committed to attending meetings they haven't shown (last fall; two different planned meetings to discuss Bellona Ave.). Our group believes, at this point, that we've had too many emails, too many Zoom meetings, too many one-offs. We need a collective, agreed-upon strategy and we need leadership to act on and implement that strategy.

Both of our groups--MBASN! and the Tunbridge PTO--await responses.

Good morning:

On behalf of Make Bellona Ave. Safer NOW! (MBASN!), a group that includes over 70 people, all of whom are copied in on this email, I'm writing to request a meeting with DOT officials about plans for Bellona Ave. At our meeting on January 28th, BCDOT officials promised actions "within a month." Nothing happened. Just a couple of weeks ago, according to Jayne Miller's reporting, BCDOT officials stated that plans were in process to respond to resident's requests by the end of April or early May. In addition, I received correspondence from Ms. Galloway which said, "I am coordinating with my BCDOT colleagues and we will be in touch."

As of today, nothing has been done and nobody has "been in touch." Our group finds this lack of responsiveness unacceptable. We continue our work, however. We had two meetings last week and have unanimity within our group on the things we believe are essential to making Bellona Ave. safer. (See below for our

findings and actions.) Furthermore, we continue to expand our efforts, adding more people to our group and collaborating with other organizations to address Bellona Ave. and traffic and safety issues on York Rd., near The Tunbridge School, located at [5504 York Rd.](#) We want everyone to understand that not only is our group not going away--we are growing stronger.

Today, as previously, we ask BCDOT officials the same questions: What are its plans for making Bellona Ave. safer, when can we meet to discuss these plans, and when will these plans be implemented?

### **Summary of Key Actions and Agreements from MBASN! Meetings**

The  
group identified the following problems:

1.

Excessive speed of cars and trucks

2.

Volume of traffic

3.

The road is too often perceived as a cut through--with traffic coming from both Northern Parkway and York Rd.

4.

No crosswalks

5.

Drivers are distracted

6.

The bend in the road is excessively dangerous

**The group has 100% agreement on the following solutions:**

1.

We need to communicate the message, through various actions, that the road is not a cut through or simply for commercial usage by large trucks. People live along the road and lots and lots of people are trying to cross the street for different purposes, including children, neighbors walking pets, and all kinds of people trying to get over to Belvedere Sq. We think a comprehensive approach is necessary.

2.

We need signage that clearly states what drivers are supposed to do--slow down due to blind turns, hidden entrances, watch for pedestrians, no large trucks, etc. The signage needs to be updated and clear and easy to see. When drivers enter Bellona from either Northern Parkway or York they need to know they just can't sprint from one end to the other. So we believe new signage needs to be put in place, with other actions, and then prominent, temporary warning signs should be in place signaling change.

3.

We think the key strategy is to construct a number of raised crosswalks along Bellona--as many as four. One has already been contemplated by DOT at Lortz Lane. There should be another at Brackenridge Ave. There should be one at Rosebank Ave. and there should also be one right near Lyman Ave. These raised crosswalks would both provide safe passage for pedestrians and slow down cars and trucks. These raised crosswalks must be well marked with good signage.

4.

The light at Northern Parkway needs to include time left-turned signals for both north and southbound traffic.

5.

We need vehicle height motion detectors to address oversized truck issues.

6.

We need a camera that checks southbound speed. Right now there is only one for northbound traffic.

7.

Putting red light cameras on the intersection of Northern Parkway would help.

Distinguished Neighbors and Helpers --

Thanks to all on the thread who are helping with these issues, especially Will.

As a 19-year resident of Bellona, I would like to use my "reply to all" to specifically call out our Councilman, Mark Conway, for doing far too little to help. A calm and sensible Will can help coordinate meetings with this group, but you should know, Mr. Conway, that some of us individually are quite fed up, especially with truck problems that were brought to DOT's and our Council office's attention more than three years ago.

I am attaching a document with photos of a tiny sampling of the many, many trucks that have illegally traveled Bellona. This does not include any number of trucks that have proceeded down Croydon and had to either back all the way out at the narrow curve, or that have swiped parked cars in the process of getting through.

Here are my complaints:

- Truck problems are a result of existing traffic laws being neglected. It should not require a task force or a large group of citizens complaining before laws that are already on the books are honored. Why is it so hard in Baltimore City to simply get support for rules that are already in place and that taxpayers are counting on?
- Many of our truck issues are the result of traffic and parking changes on other nearby roads and decisions being made without regard to the larger picture. Our truck traffic is markedly worse since parking lane changes were made on York Road. Somewhere in the decision chain there ought to be accountability from someone. At the very least, you could not let the domino effect that is impacting our neighborhood go on for so long before engaging. As of today, I still do not understand why basic signage has not been added or updated since these conversations started in 2019.
- A fair number of truck violators are City vehicles. The attached photos verify this. This is a problem you should easily be able to address among City departments.
- Many, many other trucks -- including weekly tractor trailers from Sysco and Pepsi, and large waste trucks from Waste Management -- are in this area in service of businesses on the York Road corridor. It should not be that difficult for your office to prepare an area map, highlight APPROPRIATE truck routes, and share it with the loading docks of companies and restaurants in this district until drivers get the message.
- There also needs to be pressure on DOT to update GPS registries with truck restricted routes that currently, errantly, direct trucks to streets like Bellona and Croydon.
- Finally, someone in City government owes us an explanation for why Bellona is still a two-way street when it clearly cannot accommodate all the traffic, parking, and pedestrians in this neighborhood. Our neighbors remember this street as being one-way, and the unwise change to try to force a second direction of traffic is a City traffic idea gone awry that needs to be corrected.

Thank you, Ms. Park, for the email and sharing your suggested solutions to the issue.

I understand your frustrations and agree that Will has had to take on far too much responsibility in leading this issue. Our office is frustrated as well at the danger your neighborhood has lived with for far too long.

For some brief context, Councilman Conway has been in office since December 2020 and did not receive transition materials from his predecessor regarding the issue. As a result, our office has only been engaged directly since August 2021, in response to Will reaching out to our office on behalf of the nearby neighborhood(s).

I do apologize for the lengthy transition period as our office was brought up to speed on this issue and its longstanding nature. We recognize almost a year of pushing our office and DOT is exasperating, especially on top of all your years of advocacy with previous representatives in office.

To summarize our involvement so far:

- Councilman Conway submitted a letter to Director Sharkey of DOT back in September urging his team to find a traffic calming solution after arranging meetings with multiple agencies and neighbors last summer. That letter is attached.
- DOT held a small community meeting in late January to hear concerns once again, and it was our understanding that short-term and long-term solutions would follow.
- We have since established recurring monthly meetings between our office and DOT, in which this topic has been a prominent agenda item every single time. In these meetings, we have relayed your and your neighbors' suggestions for solutions.

Councilman Conway is looking forward to meeting you all again in-person again, but disappointed that it continues to be under the same circumstances. What I can say right now is that neighbors' concerns, fears, and thoughts have been passed to the appropriate people and agencies repeatedly by the councilman himself and with the clear expectation that action must be taken. But council offices and members are also limited in their ability to specify and direct the operations of agencies (e.g., ordering certain traffic calming measures to be installed) when processes for those operations, however flawed, exist.

We will continue strategizing along with you all and pressuring DOT's leadership to take action.

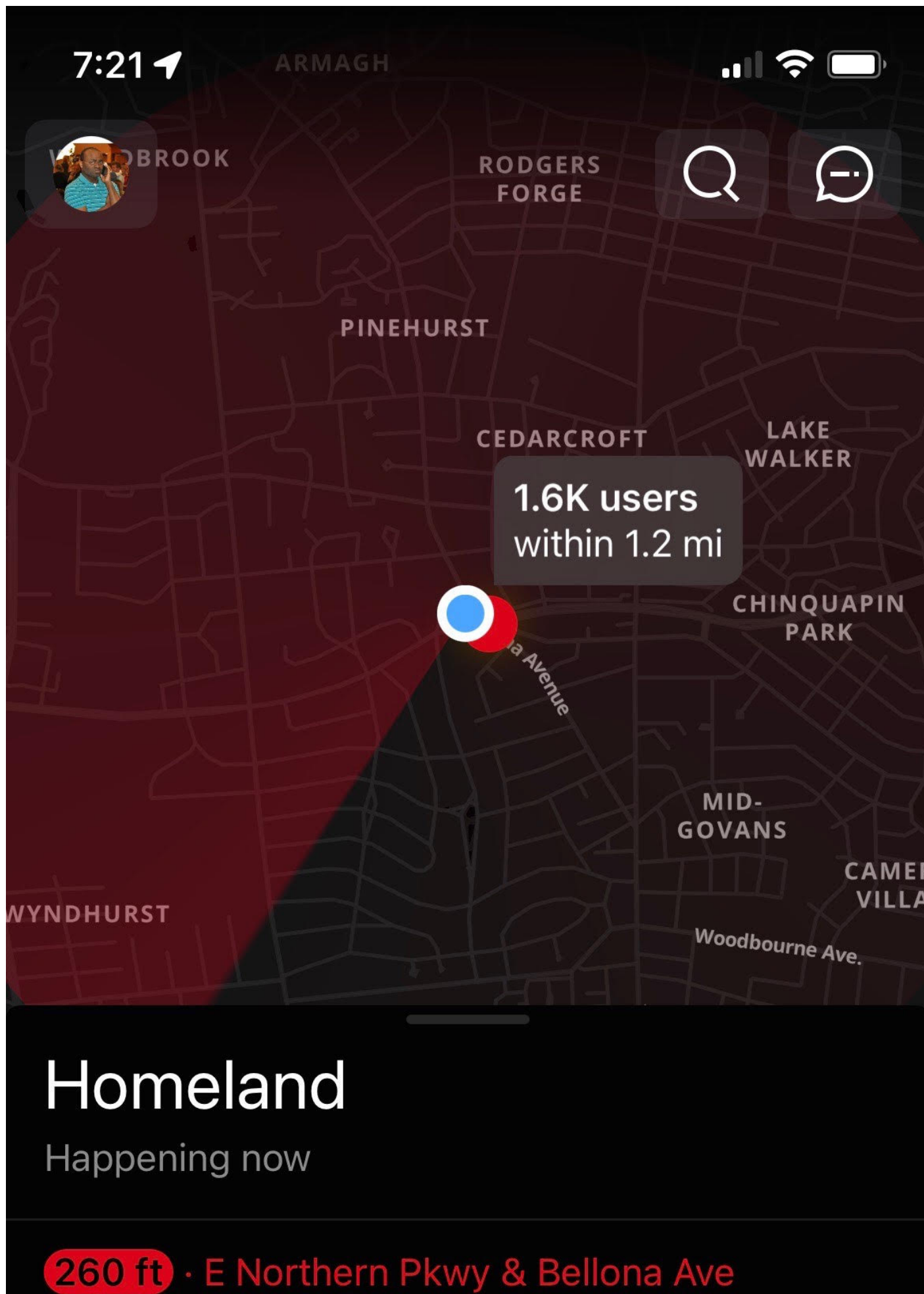

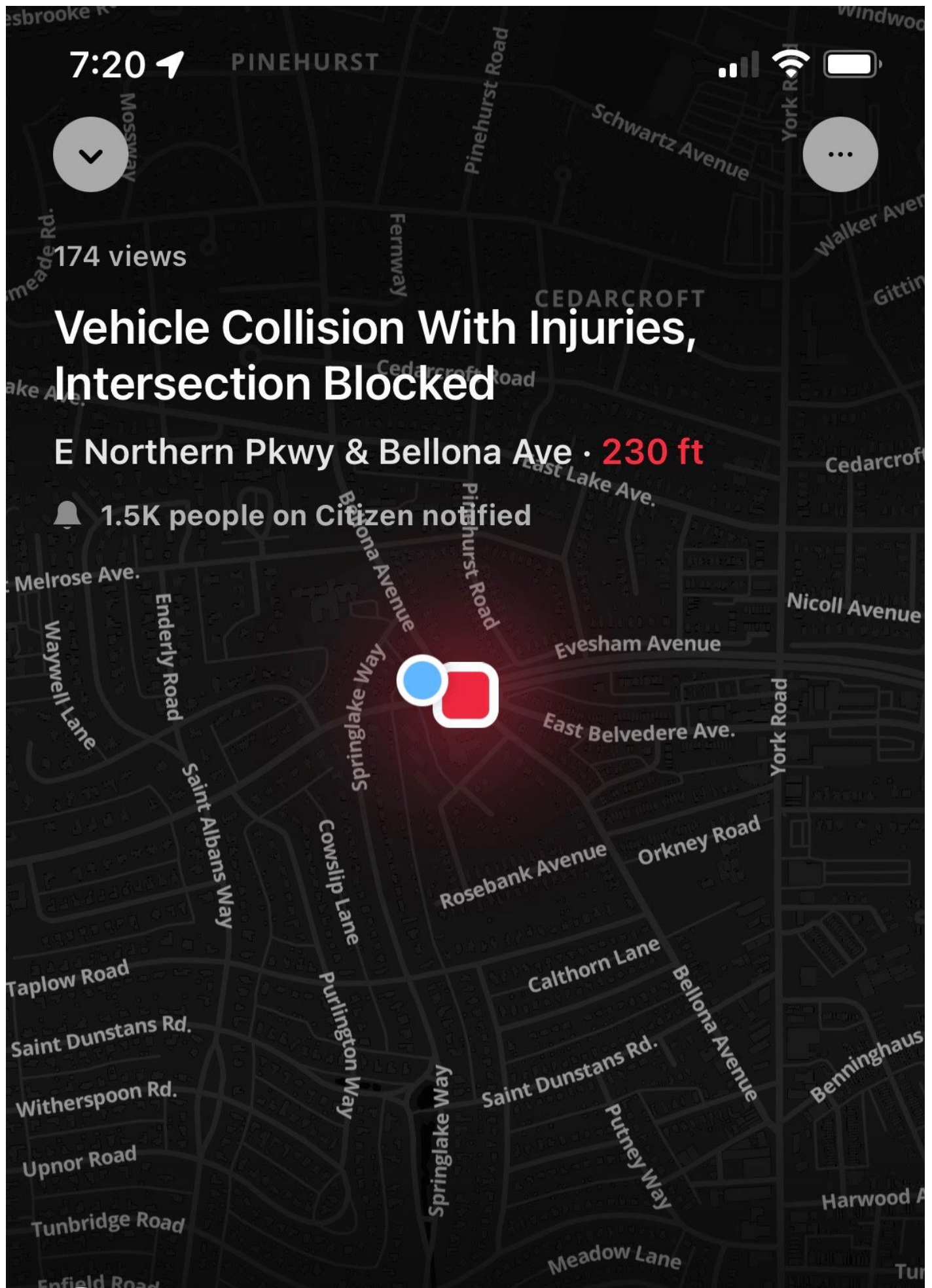
