Please complete all of the fields on this form to request a trash can or recycling cart and email the completed form to DPW.trashcans@baltimorecity.gov or mail to Baltimore City Department of Public Works, Attn: Municipal Trash Can Program, 3311 Eastbourne Ave, Baltimore, MD 21224.

This form must be received, with all supporting documentation, within ten (10) calendar days of your Service Request creation date. Your request will be reviewed for accuracy and you will be notified of your eligibility to receive a new trash can or recycling cart. Failure to provide a completed New Homeowner Verification from within ten (10) calendar days will result in the closure of your service request.

Please note: All trash cans and recycling carts belong to the City of Baltimore and are associated with a specific address. Trash cans and recycling carts are to remain at the assigned address, even if the homeowner moves.

This Deed, made this 20 day of May, 2022 by and between Lucille J. Jeannetta, party of the first part, Grantor; and Ronald Edwin Trzcinski, as Sole Owner, party of the second part, Grantee.

- Witnesseth -

That for and in consideration of the sum of FIFTY THOUSAND AND 00/100 Dollars (\$50,000.00), which includes the amount of any outstanding Mortgage or Deed of Trust, if any, the receipt of which is hereby acknowledged, the said Grantor does grant and convey to the said Ronald Edwin Trzcinski, as Sole Owner, his personal representatives and assigns, in fee simple, all that lot of ground situate in the City of Baltimore, State of Maryland and described as follows, that is to say:

Beginning for the same on the northeast side of Shamrock Avenue at the distance of 98 and 89/100ths feet southeasterly measured along the northeast side of Shamrock Avenue from the southeast side of Brehms Lane which place of beginning is at a point in line with the center line of a partition wall there erected and running thence southeasterly binding on the northeast side of Shamrock Avenue 18 feet to a point in line with the center line of another partition wall there erected, thence running northeasterly to, through and along the center line of said last mentioned partition wall to the end thereof and continuing the same course in all 100 feet to the southwest side of an alley 16 feet wide there situate, thence running northwesterly binding on the southwest side of said alley with the use thereof in common with others 18 feet to meet a line drawn northeasterly from the place of beginning to, through and along the center line of the partition wall first above mentioned in this description, thence running southwesterly reversing said line so drawn and binding thereon 100 feet to the place of beginning.
