Dear Council Member Middleton:

I am a resident of Roland Park and am asking for your assistance with the removal of a dead tree that is, I believe, the City's responsibility, in Church Alley behind the home located at 506 Woodlawn Road, Baltimore Md 21210. I have lived in Roland Park for nearly 30 years.

My name is Scott Conover and I live at 502 Woodlawn Road in the property adjoining 506 Woodlawn Road. The tree, pictured in the photos below, has been dead for over a year, and has begun dropping significant limbs onto my garage and into local yards and the alley. Two large limbs have already struck my garage roof. The tree is a significant hazard to people and property and should be taken down immediately.

Our neighbors, the Hirschfields, live at 506 Woodlawn Road and I believe they have sought your help with this matter as well.

Please let me know who else to contact or what to do to solve this imminent threat to the safety of our neighborhood.
