# **Barth Syndrome UK Safeguarding Policy**

#### <u>Intent</u>

This policy will enable Barth Syndrome UK (BS UK) to demonstrate its commitment to safekeeping all children, young people, vulnerable adults, staff and volunteers and anybody else with whom we work. BS UK acknowledges its duty to act appropriately to any allegations, reports or suspicions of abuse.

It is important to have the policy in place so that the trustees, volunteers and anyone else working on behalf of BS UK can work to firstly prevent abuse, and, secondly - in the event of abuse occurring - being aware of the correct procedures to follow.

The Policy Statement and Procedures have been drawn up in order to enable BS UK to: -

- Promote good practice and work in a way that prevents harm, abuse and coercion occurring and to provide a safe and trusted environment for all.
- Ensure all volunteers are suitable for working with children, young people and vulnerable adults.
- Ensure any event organised by BS UK is delivered safely, with the needs of children, young people and vulnerable adults being uppermost when planning.
- Ensure that any allegations or suspicions of abuse are dealt with appropriately, in accordance with the law and in line with best practice.
- Ensure the person experiencing abuse is henceforth protected and supported, and to stop further abuse occurring.

The policy applies to all BS UK trustees, paid staff, volunteers, and anyone else working on behalf of BS UK.

BS UK acknowledges that the welfare of all people, and specifically children, young people and vulnerable adults, is paramount, and that they have the right to be protected from harm and exploitation.

As an internet-based rare disease charity, trustees, volunteers and staff typically work from their own homes and do not come into regular contact with each other. Trustees, staff and volunteers have little or no unsupervised contact with children and vulnerable adults. The only exception to this could be during Family Outreach events when children and families might mingle. However, during these events, parents are responsible for the care of their children and are always present.

Trustees, staff and volunteers who are at such events will ensure that they are not alone with other children and/or vulnerable adults, unless they have successfully passed a Disclosure and Barring (DBS) check.

In order to implement the policy, BS UK will work to: -

Promote the rights of all people to live free from abuse, exploitation and coercion.

- Manage our services in a way which promotes safety and helps to prevent abuse, exploitation and coercion.
- Recruit trustees and volunteers safely, ensuring all necessary background and assurance checks are made.
- Ensure the safety and wellbeing of people who do not have the capacity to decide how they want to respond to the abuse being experienced.
- Promote the freedom and dignity of the person who has or is experiencing abuse.

### BS UK will: -

- Ensure that all trustees, volunteers, and anyone working on behalf of BS UK, are familiar with this policy and procedures.
- Act within its confidentiality policy and will typically gain permission from service users before sharing information about them with another agency or third-party.
- Alert all concerned parties (where possible) of their responsibilities to act and intervene where it appears that a child, young person or vulnerable adult is at risk.
- Respond in a timely manner to any concerns raised, or allegations received and ensure that appropriate and confidential records are kept.
- Inform the appropriate services where a child, young person or vulnerable adult is (or appears to be) in danger or at risk, including the passing of such information to another agency without that person's consent.
- Endeavour to keep abreast of developments nationally relating to the prevention of abuse and welfare of children, young people or vulnerable adults, and to regularly review this policy.
- Ensure that the Designated Named Person understands his/her responsibility to refer incidents of all abuse to the relevant statutory agencies (Police/Social Services, Health Agencies and Charity Commission).

The Designated Named Person with regards to this Safeguarding Policy for BS UK is the Chairperson.
