Cookie policy of the www.biagroup.com website

This document is written in several languages to facilitate its understanding. In case of discrepancies between the various language versions, the French version takes precedence.

A cookie is a small text file that may be stored on your computer when you visit websites.

Information is stored in a text file, such as your choice of language for the Website. When you visit the Website again later, this cookie is sent back to the site. In this way, the Website recognises your browser and can, for example, remember your choice of language.

Cookies usually also have an expiry date. Some cookies are, for example, automatically deleted when you close your browser (so-called session cookies), while others remain on your computer for a longer period of time, sometimes even until you delete them manually (so-called permanent cookies).

Why do we use cookies?

The Website uses three types of cookies:

- essential cookies ;
- functional cookies ;
- analytical cookies.

BIA sets cookies to manage the content and to enable the optimal functioning of its Website. It is not possible to refuse these cookies if you want to visit the Website.

In terms of analytical cookies, BIA uses (indicative and non-limitative list, subject to change) Google Analytics, Linkedin Insight Tag, Facebook Pixel and Hotjar, which provide us with information about your use of our websites, including the following: the pages you visited, the links you clicked, the time you spent on a page, the products or services you designed using our configurator, the device you used, etc. This data enables us to understand how people use our website and to ensure that it functions properly. This data is not used for marketing or advertising purposes.
