Once you have set up your business you might decide to join your local Chamber of Commerce, membership of which gives you access to certain support and services financed by membership fees. These are largely self-selecting, self-regulating groups although the British Chambers of Commerce have developed their own accreditation and quality assurance system for their members. The services provided by local Chambers vary enormously but generally they can provide you with information and advice cheaply and quickly. They generally attract a high proportion of local owner-managers and are therefore good places for local networking.

Many business sectors have trade associations, membership of which gives you access to certain support and services. As with Chambers, the services these associations provide vary enormously but generally they can provide you with information and advice cheaply and quickly. This website gives a list of trade associations. Information on the services offered can be obtained from the website of the relevant association.

BANKS

Many of the banks also provide free information and advice. For example, Barclays provides free Business Information Fact-sheets which give information on size of market, types of customers, competition, advertising, start-up costs, qualifications and legal matters relevant to particular fields of business. They also provide more general start-up information in the form of free booklets. Information on these services can be obtained from the website of the relevant bank.

The most comprehensive single source of information in the UK is the British Library Business and IP (Intellectual Property) Centre in London. The free Reader Pass gives you access to the Library's collection of over 150 million items – books, manuscripts, maps, newspapers, magazines, patents, prints and drawings, photographs and more.

- You can find images and sounds to aid in the creative process, technical literature to aid in scientific discovery and market information to help develop your competitive strategy;
- There is information on market size, trends, competition and target customers including hundreds of market research reports from companies such as Mintel, Datamonitor and Frost and Sullivan covering a huge variety of industries:
- The Library offers free online access to databases giving company, financial and industrial information such as Fame, Amadeus, OnSource, Lexis-Nexis and Dialog;
- ➤ It also houses the most comprehensive collection of patent specifications in the world over 50 million specifications from 40 countries and provides access to the most up-to-date literature on patents, trademarks, designs and copyright, together with access to extensive online search tools:
- It even has an inspirational entrepreneurial role model events programme.

BUSINESS TAXATION

VALUE ADDED TAX (VAT)



https://www.gov.uk/vatregistration Businesses with a turnover above a certain level must charge and collect Value Added Tax. Check with HM Revenue and Customs (HMRC) whether registration is necessary because of turnover level.

Need to register with HMRC and obtain a Unique Taxpayer Reference (UTR) number(s). You will need your National Insurance number (your local Jobcentre Plus can help you with this if you do not have one). Income Tax is collected on a self-assessment basis.

Sole traders or partnerships can register to have their income and expenses assessed on a 'cash basis', rather than a profit basis if it suits them. The second website gives you information on this option.

Need to make an annual Company Tax Return and file annual accounts with HMRC. If your accounts and Company Tax Return cover the same period, you can send them to both Companies House and HMRC at the same time.

PAY-AS-YOU-EARN (PAYE) INCOME TAX DEDUCTED FROM EMPLOYEES

Need to register with HMRC and deduct tax and National Insurance from all employees receiving payments (including directors) and pay over to HMRC.

Local taxation is collected through Business Rates. They are handled differently in England/Wales, Scotland and Northern Ireland. Generally the Local Authority will send you an annual Rates bill in February/March each year.

These vary for different sectors and between regions. They also change over time.

The best place to start to search is the UK Government interactive finance and support tool that allows you to search out what is available to your particular business.

British Business Bank is a government-owned business development bank dedicated to making finance markets work better for smaller businesses. Information on where finance can be obtained for SMEs can be found on this website. Two of their schemes are listed below.

Start Up Loans is a government-funded scheme that funds and mentors entrepreneurs. Applicants are assigned a 'delivery partner' who will help develop a business plan. This is assessed and funding decided by the Start Up Loans Company who can provide a low-cost unsecured loan, business mentoring and a range of business support products if the plan is approved. The fixed-rate loan must be paid back within 5 years.

Enterprise Finance Guarantee Scheme is a guarantee scheme to facilitate lending to viable businesses that have been turned down for a loan or other form of debt finance due to inadequate security or a proven track record. It is administered by the banks. Information is provided on this website.

FINANCIAL CONDUCT AUTHORITY (FCA)

The Financial Conduct Authority is the body that supervises and regulates financial institutions. It has a public register of all individuals, firms and other bodies that are authorised to offer finance and credit, as required by UK law. You can use this to check the authenticity of finance providers.
