#### Comments on the Excel file

When faunal remains of equids were not identifiable to a specific species of equid, the genus *Equus* is used. The same applies with remains not identified by an expert (for example from older excavations). Almost all sites contain remains of *Equus* not further identifiable; these are therefore not noted separately when specific species have been identified.

/ (e.g. E. hemionus/E. asinus) denotes identification to one of the mentioned species  
- (e.g. E. hemionus-E. asinus) denotes a hybrid

The occurrence of equid remains associated with human burials are marked with an 'x' in column G.  
The occurrence of complete or nearly complete equid skeletons are marked with an 'x' in column H.
