

Installation:

- Disconnect power.
- Cut a hole in ceiling Ø175mm.
- · Connect light to driver via male and female connectors.
- Select Colour Temperature (3000K, 4000K or 5500K) by toggling the switch on the driver.
- Insert plug, cord and driver into the ceiling and connect the 2-Pin mains plug to a suitable power socket.
- Lift the spring clips up on and insert light into ceiling.
- Refer page 2 "INSULATION RATING IC" for building element and insulation clearance requirements.
- Restore power.


