This electrical product should not be disposed as normal waste. Please always recycle! Check with your Local Council about your recycle options.



Installation Instructions:

- 1. Ensure mains supply is switched OFF.
- 2. Unpack the fixture and accessories carefully and place on a flat surface.
- 3. Drill holes into the mounting surface using brackets (A) as a template.
- 4. Secure the two brackets (A) to the mounting surface using screws (B). Rawl plugs (C) need to be used for concrete mounting surface (Figure 1).
- 5. Attach the fixture onto the mounting brackets by sliding one side of the base onto the bracket, then pushing the other side on firmly (Figure 3).
- 6. Unfasten diffuser locking clips (D) on one side of the fixture and let the diffuser hang down (Figure 1).
- 7. Turn the retainer (Figure 4) to the 'Open' position and remove the metal reflector/heat sink.
- 8. Using one of the three knockouts on the fixture, drill a hole and attach a IP65 cable gland (M20 Cable gland provided in the gift box).
- 9. Run mains wire through the cable gland (Figure 5) into the fixture and connect the Live (L), Neutral (N) and Earth according to the markings on the terminal block in accordance with Australian Standards. Make sure the connections are firm and secure.
- 10. Refit the metal reflector/heatsink and turn retainer until it locks firmly.
- 11. Ensure cable gland is tightened sufficiently in order to prevent water ingress.
- 12. Install diffuser (A), by aligning it correctly with the base and fasten clips (E) (Figure 6).
- 13. Turn the power on.
