

UNDER CABINET POWER STATION WITH LED LIGHT 20229/11

Congratulations on the purchase of your new Brilliant Under Cabinet Power Station. Before first using, it is most important that you read and follow the instructions on this document, even if you feel you are quite familiar with this type of product. Find a safe place and keep this document handy for future reference.


IMPORTANT SAFEGUARDS:

- This product is not intended to be mounted in floors.
- Any unauthorised modification might impair the product safety and will void Brilliant Warranty.
- If the external flexible cable or cord of this luminaire is damaged, it shall be exclusively replaced by the manufacturer or his service agent or a similar qualified person in order to avoid a hazard.
- Do not use in areas where the product can get wet.

INSTALLATION:

- 1. Find a suitable location for power station 'A', e.g.: under cabinet, on the wall or on a desk.
- 2. Decide which side the flex and plug needs to exit from the back of power station. Use a plier to remove the corner piece 'B' on end cap of that side to feed cable through.
- 3. Remove screw hole covers 'C' at both ends of power station by inserting a flat head screw driver into the slot on the cover and prying open.
- 4. Use screws and suitable fixture system to secure the power station 'A' either to the wall or to the bottom of bench. Use top or bottom holes of power station 'A' depends on its mounting position. Use two screws on each side of power station 'A' (4pcs screws in total) to secure it.
- 5. Refit screw hole covers 'C'.


6. Insert the plug into a wall socket or surface mount socket. Turn on the power. The power board is ready for use.





OPTIONAL TABLE CLAMP (20236/06) FOR POWER STATIONS (not included, need to purchase separately) **INSTALLATION:**

- 1. Find a suitable location for power station 'A' and table clamp 'B', e.g.: on the edge of a desk or bench. The mounting surface thickness should be between 10 and 55 mm.
- 2.Remove screw hole covers 'C' at both ends of power station by inserting a flat head screw driver into the slot on the cover and prying open.
- 3. Use four screws 'D' to secure the power station 'A' to table clamp use holes on each side of power station 'A'.
- 4.Refit screw hole covers 'C'.
- 5. Turn the handle 'F' to lock the clamp mechanism 'B' until it can not be turned
- 6.Insert the plug into a wall socket or surface mount socket. Turn on the power. The power board is ready for use.






UNDER CABINET POWER STATION WITH LED LIGHT 20229/11

Operation:

The UNDER CABINET POWER STATION is equipped with a built-in 9W dimmable LED light. Switch ON/OFF LED light – Quickly press dimmable switch 'D' once. Dim LED light – Press and hold dimmable switch 'D'.

The UNDER CABINET POWER STATION is also equipped with USB ports. Switch ON/OFF USB ports – press ON/OFF button 'E'.
